9. Public Comment



Members of the public may address the SFMTA Board of Directors on matters that are within the Board's jurisdiction and are not on today's calendar.

Speaker shared that he sent an email about taxi medallions.

Donte Vickers expressed concern about balancing the budget by cutting working conditions, benefits, and essential staffing.

Richard Johnson shared about violations on Hayes Street and expressed frustration about the agency's inaction.

Timothy Trickel expressed concern about maintenance and supervisor staffing being stretched too thin.

Philip Lim expressed concern on behalf of transit maintenance staff and being asked to make additional staffing reductions and operational cuts.

Richard Bernal expressed concern for staff, declining morale, stress and limited leadership transparency.

Steve Ramos expressed concern about bus maintenance and potential workforce reductions.

Griffin Lee expressed support for only opening front doors on buses to recoup fares and collect more revenue.

Chris expressed concern over eliminating premium shifts as a cost-saving measure, sharing that it could lead to reduced efficiency and bigger problems.

Carrie Ong expressed concern over a recent car cleaner signup and changes to shifts.

Michael Petrelis expressed concern about a loss of parking spaces on the lot near the Castro theatre.

- A. RESCIND – TOW-AWAY, NO STOPPING, 7 AM TO 9 AM, EXCEPT SATURDAY AND SUNDAY, Prague Street, east side, from Geneva Avenue to South Hill Boulevard.
- B. RESCIND – WHITE ZONE, PASSENGER LOADING, 7 AM TO 10 PM, DAILY, Jones Street, east side, from 88 feet to 132 feet north of McAllister Street.
- C. RESCIND – WHITE ZONE, PASSENGER LOADING, AT ALL TIMES, Jones Street, east side, from Golden Gate Avenue to 131 feet southerly.
- D. ESTABLISH – TOW-AWAY, NO STOPPING ANY TIME, Jones Street, east side, from Golden Gate Avenue to 175 feet southerly.
- E. RESCIND – BUS ZONE, 24th Street, north side, from Castro Street to 65 feet westerly.
- F. ESTABLISH – YELLOW METERED ZONE, COMMERCIAL LOADING, 30-MINUTE TIME LIMIT, 9 AM TO 6 PM, MONDAY THROUGH SATURDAY, 24th Street, north side, from 13 feet to 65 feet west of Castro Street.
- G. RESCIND – TOW-AWAY, NO STOPPING, EXCEPT PERMITTED CAR SHARE, Bartlett Street, east side, from 3 feet to 20 feet south of 26th Street.
- H. ESTABLISH – TOW-AWAY, NO STOPPING, EXCEPT PERMITTED CAR SHARE, Bartlett Street, east side, from 20 feet to 37 feet south of 26th Street.
- I. ESTABLISH – RED ZONE, Bartlett Street, east side, from 26th Street to 20 feet southerly.

California Environmental Quality Act (CEQA) Appeal Rights under S.F. Admin. Code Chapter 31: For identified Approval Actions, the Planning Department or the SFMTA has issued a CEQA exemption determination or negative declaration, which may be viewed online at the Planning Department's website. Following approval of the item by the SFMTA Board, the CEQA determination is subject to appeal within the time frame specified in S.F. Administrative Code Section 31.16 which is typically within 30 calendar days. For information on filing a CEQA appeal, contact the Clerk of the Board of Supervisors at City Hall, 1 Dr. Carlton B. Goodlett Place, Room 244, San Francisco, CA 94102, or call 415.554.5184. Under CEQA, in a later court challenge, a litigant may be limited to raising only those issues previously raised at a hearing on the project or submitted in writing to the City prior to or at such hearing, or as part of the appeal hearing process on the CEQA decision.

Board of Supervisors review of certain SFMTA Decisions: Certain parking and traffic modifications as well as Private Transportation Programs that involve certain parking modifications can be reviewed by the Board of Supervisors. These decisions are subject to review within 30 calendar days after they are made by the SFMTA Board of Directors.
