**Resolution amending Division II of the Transportation Code to streamline the Code by removing lists of restrictions that state law does not require to be published.**

The Municipal Transportation Agency Board of Directors of the City and County of San Francisco enacts the following regulations:

Section 1. Article 100, 200, 500, 600, and 700 of Division II of the Transportation Code is hereby amended by revising Sections 101, 201, 501, and 503, and by deleting Sections 601, 602, 701, and 702 to read as follows:

**SEC. 101. DEFINITIONS.**

Any words or phrases that are not defined in the Vehicle Code or in Division I of this Code shall have the meanings set forth below.

**Transit-Only Area.** The locations that are reserved for the use of public transit vehicles, *as specified in Article 600 of this Division II and other authorized vehicles.*

(b) **Public Hearings.** The following Parking and traffic measures may be implemented following a Public Hearing by the City Traffic Engineer or, if a project includes actions in this subsection and subsection (c), the City Traffic Engineer may recommend a hearing at the SFMTA Board of Directors:

~~(13) Designate Temporary Transit only Areas and create associated tow-away zones, as authorized in Section 602 of the Transportation Code.~~

(13) Determine the locations for Longer-Term Closure of Parking Spaces for purposes of issuing a permit for a Curbside Shared Space as defined by Administrative Code Chapter 94A.

(c) **SFMTA Board of Directors' Action Required.** The following Parking and traffic measures may not be implemented without prior approval of the SFMTA Board of Directors, taking into consideration the recommendation of the City Traffic Engineer:

~~(12) Establish transit only lane regulations, except as specified under the authority granted to the City Traffic Engineer in subsection (b)(13) above. Designate locations and hours of operation of Transit-Only Areas for use of public transit vehicles and other authorized vehicles.~~

(13) Establish speed limits on Streets consistent with the requirements of the California Vehicle Code.

**SEC. 501. VEHICLE WEIGHT RESTRICTIONS.**

(a) The operation of a vehicle with gross weight in excess of 6,000 pounds on the Streets listed in Section 501(b), or the operation of a vehicle with unladen weight in excess of 18,000 pounds on any Street *designated by the SFMTA Board of Directors listed in Section 501(e)* is a violation of Division I, Section 7.2.77 (Weight Restricted Streets).

*(b) — 6,000 lbs Limits. No person shall operate a vehicle of a gross weight in excess of 6,000 pounds on the following Streets:*

(1) Any vehicle which is subject to the provisions of Section 1031 to 1036, inclusive, of the California Public Utilities Code and which has received a certificate from the CPUC pursuant to those Sections declaring that the public necessity and convenience require the operation of the vehicle, provided that the certificate authorizes that vehicle to be operated within the City, and the vehicle is being operated for the purpose authorized in, and consistent with the terms of, the certificate. This exemption shall not apply to vehicles operated as round-trip sightseeing tour service as defined by the CPUC;

(2) Any commercial vehicle coming from an unrestricted Street having ingress and egress by direct route to and from that portion of the restricted Streets set forth above, when necessary for the purpose of making pickups of refuse, pickups or deliveries of passengers, goods, wares and merchandise from or to any building or structure located on such restricted Street, or for the purpose of delivering materials or equipment to be used in the actual and bona fide repairs, alteration, remodeling or construction of such restricted Street, or for any building or structure upon such restricted Street for which a building permit has previously been obtained;

- (3) Any vehicle owned by a public utility while in use in the construction, installation or repair of any public utility;
- (4) Transit vehicles operated by the SFMTA along a regularly scheduled route;
- (5) School buses when operated for the transportation of school pupils;
- (6) Any vehicle owned by the City while being used in the course of official business; and
- (7) Emergency vehicles.

**SEC. 503. COMMERCIAL PASSENGER VEHICLES; RESTRICTED STREETS.**

(a) **Prohibition.** Operation of a commercial vehicle with seating capacity of nine or more persons (including the driver), used or maintained for the transportation of persons for profit, upon any Street ~~designated by the SFMTA Board of Directors listed in Section 503(b)~~ is a violation of Division I, Section 7.2.87 (Commercial Passenger Vehicle Restrictions).

~~(b) — **Restricted Streets.** Except as otherwise provided in this Code, no person shall operate a commercial vehicle with seating capacity of nine or more persons, including the driver, used or maintained for the transportation of persons for profit, upon the following Streets or within the following areas:~~

~~SEC. 601. DESIGNATED TRANSIT ONLY AREAS.~~

~~(a) — The locations listed in this Section 601 are designated as Transit only Areas. Any vehicle operating within a Transit only Area during times that the Transit only Area is enforced is in violation of Transportation Code, Division I, Section 7.2.72 (Driving in Transit only Area).~~

~~(1) — Cable Car Lanes on Powell Street southbound, Between Sacramento Street and Sutter Street and, northbound, Between Sutter Street and California Street. Except as to cable cars, Municipal Railway vehicles, and authorized emergency vehicles, no vehicle may operate within, over, upon, or across the cable car lanes, or make any left or U turn on the exclusive cable car lanes on Powell Street between Sacramento and Sutter Streets except to pass a disabled vehicle.~~

~~(2) — Cable Car Lanes On California Street (Eastbound) Between Powell Street and Grant Avenue and (Westbound) Between Stockton and Powell Streets. Except as to cable cars, Municipal Railway vehicles, and authorized emergency vehicles, no vehicle may operate within, over, upon, or across the cable car lanes, or make any left or U turn on the exclusive cable car lanes on California Street, eastbound, between Powell Street and Grant Avenue and westbound between Stockton and Powell Streets, except to pass a disabled vehicle.~~

For purposes of this Section 602, “Temporary Transit-only Areas” are defined as the locations that are reserved for the use of buses, streetcars, taxis, bicycles, authorized emergency vehicles, vehicles preparing to make a turn, vehicles entering into or exiting from a stopped position at the curb, and/or vehicles entering into or exiting from a driveway, as specified in this subsection (a) and in any determinations made by the City Traffic Engineer to designate such locations as authorized by subsection (b) to reduce the impact of traffic congestion resulting from the COVID-19 emergency referenced in the Proclamation of the Mayor Declaring the Existence of a Local Emergency, dated February 25, 2020 (“COVID-19 Emergency”).~~
