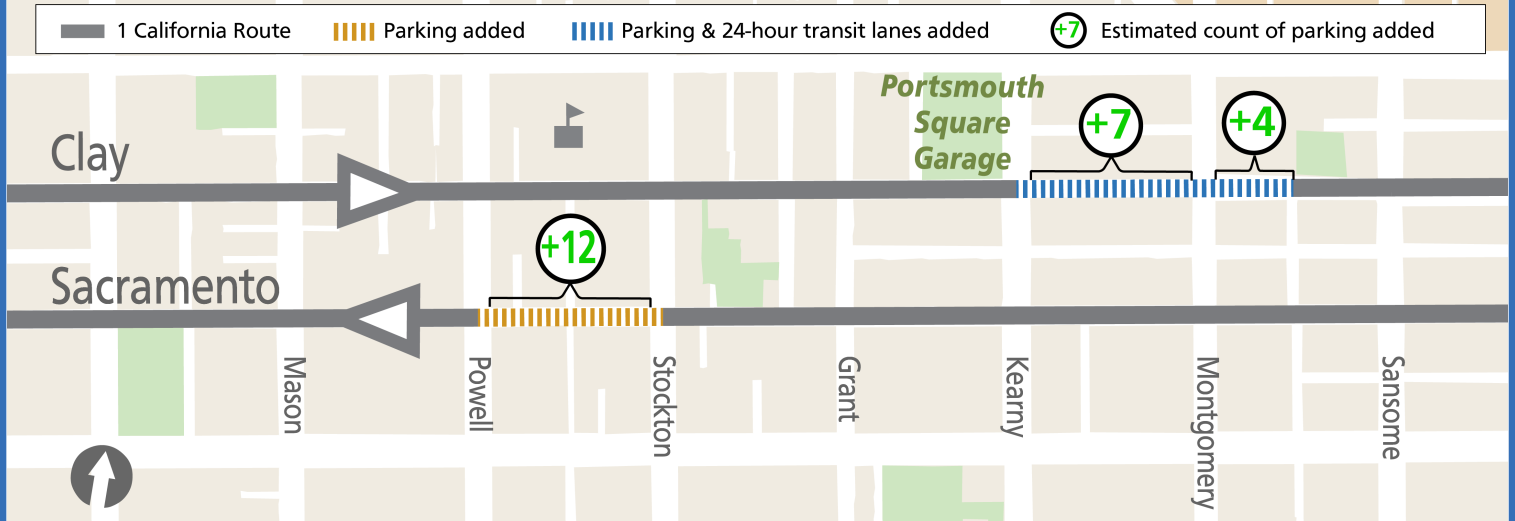


# Proposed Street Changes

## Chinatown Parking & Transit Improvements



To add parking near Portsmouth Square, Chinatown merchants requested changes to tow-away restrictions. In response, the SFMTA has identified opportunities to add more parking. These changes also improve transit and loading. This proposal responds to merchant requests for additional street parking.

On Clay Street between Kearny and Sansome streets:

- Removal of the 7-9 a.m. and 3-6 p.m. tow-away zone
- Expand curbside parking and loading hours. This would increase parking
- The adjacent mixed traffic lane changed to a 24-hour transit lane. The transit lane would allow use by right-turning vehicles and taxis

On Sacramento between Powell and Stockton streets:

- Removal of the existing 4-6 p.m. tow-away zone loading. This parking change would not affect the existing transit lane
- Expand curbside parking and loading hours. This would increase parking

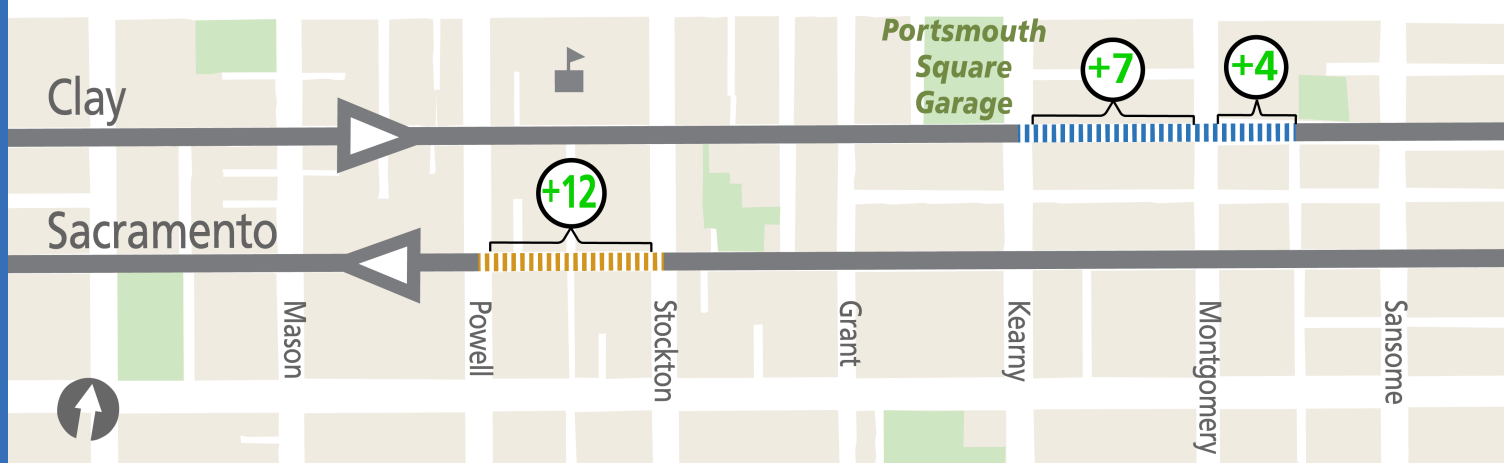

## 華埠停車與公交改善計劃

— 1號巴士    ■■■■ 新增停車位    ■■■■ 新增停車位及公車專用道    ⊕ 預估的新增停車位



為了在花園角（Portsmouth Square）周邊增加停車位，華埠商家提出要求，希望調整拖車的規定。對此，舊金山交通局 (SFMTA) 已找出可增加更多停車位的機會。這些調整同時也將改善公共交通及商戶的裝卸作業。此方案回應了商家對新增路邊停車的訴求。

Clay 街（Kearny 街夾 Sansome 街之間）的調整方案：

- 取消上午 7 點至 9 點及下午 3 點至 6 點的拖車時段
- 延長路邊停車與裝卸時段，以增加停車位
- 將相鄰的車道調整為 24 小時公車專用道；該專用道允許車輛與出租車右轉

Sacramento 街（Powell 街夾 Stockton 街之間）的調整方案：

- 取消下午 4 點至 6 點裝卸時段的拖車規定；此項調整將不影響現有的公車專用道
- 延長路邊停車與裝卸時段，以增加停車位
