Taxi Meeting Code of Conduct

Good etiquette in meetings requires all participants to adhere to a number of ground rules. Ground rules are the standards of conduct expected at Taxi Outreach Meetings and are important to ensure that our meetings run efficiently and effectively.

1. Speak one at a time, once recognized by the meeting chair.
2. Generally, each participant can speak on each item for 2 minutes. After everyone who wants to has spoken once, participants may speak again for 1 minute each. The chair may set and announce a different speaking time limit depending on the agenda and timing.
3. You may only speak during your allotted time and must stop speaking when your time is up.
4. No interrupting others.
5. Listen to all contributions.
6. No side conversations.
7. Keep comments on the agenda topics.
8. Treat each other with respect.
9. Staff will warn if rules are being violated. Each participant gets one warning of a code of conduct violation. If the inappropriate behavior continues, you may be asked to leave. If you refuse to leave, staff may end the meeting. If the inappropriate behavior continues, the meetings will move to fully remote. Online speakers may be muted if they are not following the rules of conduct.

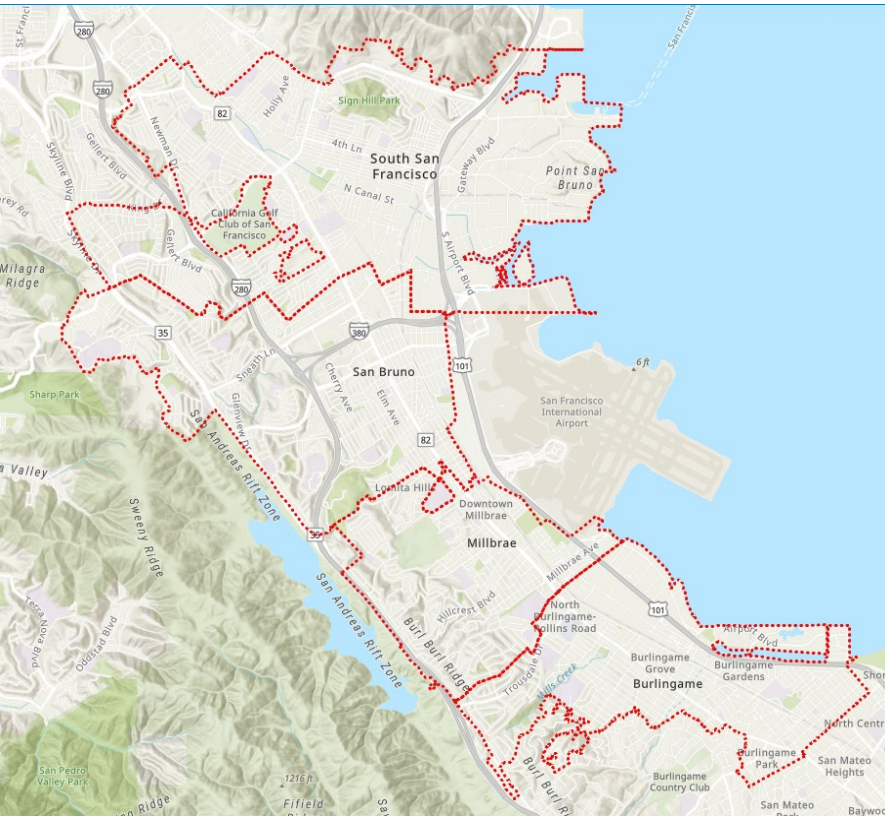
Taxi Code Reform Proposal: Flat Fare from SFO

❖ Continued Discussion From May 2026 Meeting:

Flat rate from SFO within geofenced boundary:

- Concept is to establish flat fare for short trips originating from SFO
- Fare is clear to customers – easily explainable boundaries
- Compensates drivers for very short trips
- Time of day/only certain hours is too complicated
- Fare needs to be competitive to prevent loss of volume

Taxi Code Reform Proposal: Flat Fare from SFO



❖ Proposed rate amendments:

Flat rate from SFO:

- Flat Fare: **\$24** not including fees
- Fare applies to trips within boundaries
- Fare is clear to customers
- Applies 24/7/365
- Drivers still eligible for SFO Short Line
- Meter will read \$24 from flag drop
- For trips beyond area, meter resumes normal operation.

Taxi Code Reform Proposal: Special Event Fee

❖ New Concept for Discussion:

Special Event Fee:

- Fee that Drivers can charge after specified large events
- Events include Outside Lands, games/concerts at Chase and Oracle
- Customer complaints about Drivers overcharging/flat rating
- Drivers close to venue when event ends are not able to return after first trip
- Fee would compensate driver for the event, reducing overcharging complaints

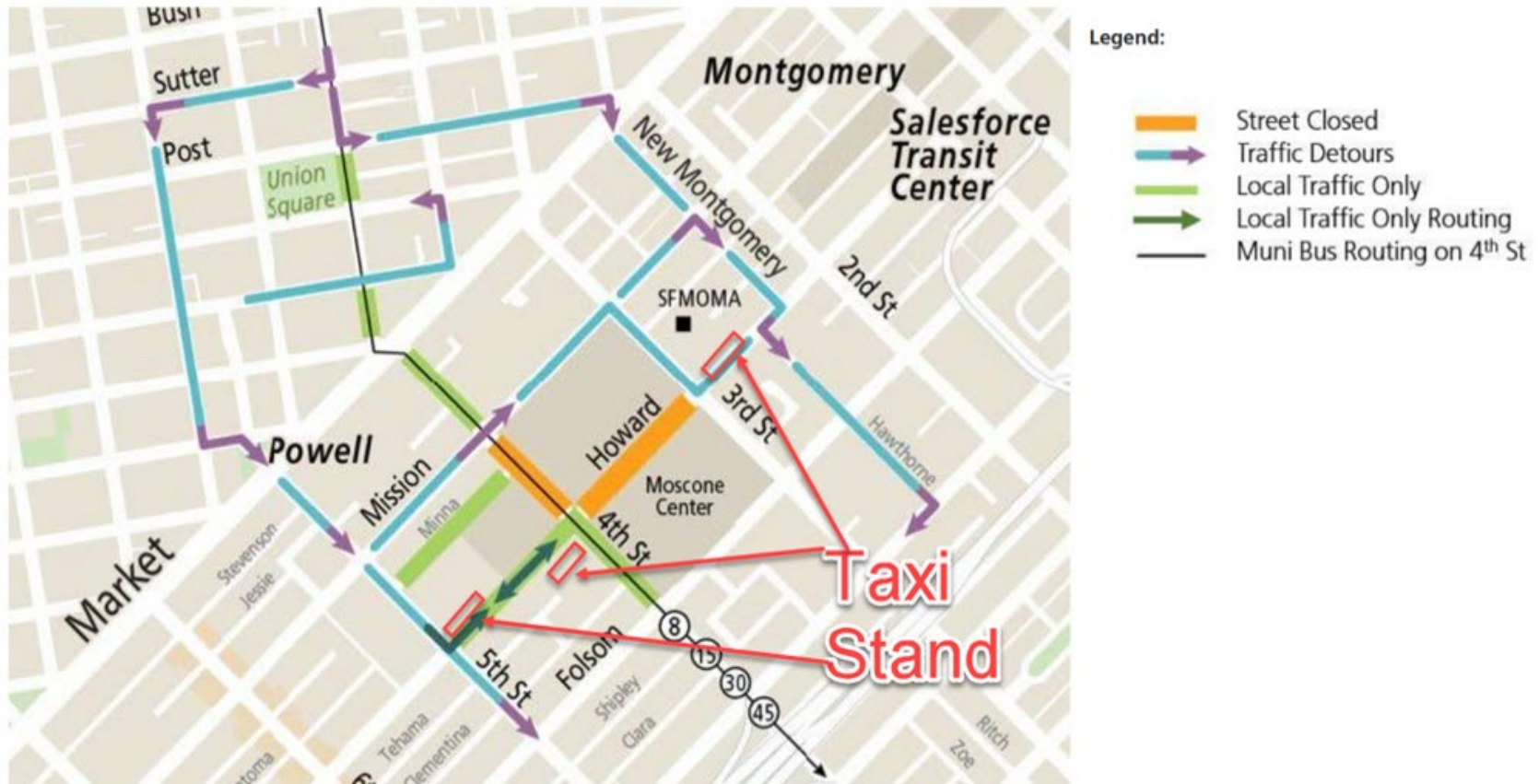
