June 6, 2015 PUBLIC HEARING RESULTS

The Sustainable Streets Division of the San Francisco Municipal Transportation Agency held a public hearing on Friday, June 6, 2015, at 10:00 AM, in Room 416 (Hearing Room 4), City Hall, 1 Dr. Carlton B. Goodlett Place, San Francisco, CA 94102, to consider the proposals listed below. This document summarizes the results of the hearing. Per Section 201 of the City Transportation Code, some items can be implemented by the authority of the City Traffic Engineer. Other items require further approval by the SFMTA Board.

1. ESTABLISH - NO TURN ON RED, 7 AM TO 7 PM, DAILY

Lincoln Way, westbound, at 19th Avenue/Crossover Drive

□ Item will be forwarded to SFMTA Board for approval and implementation.

2(a). ESTABLISH – STOP SIGN

Holyoke Street, southbound, at Silliman Street, stopping the stem of this "T" intersection

2(b). ESTABLISH - RED ZONE

Silliman, Street, south side, from west curb to east curb at Holyoke Street (60-foot red in intersection)

→ Items will be forwarded to SFMTA Board for approval and implementation.

3(a). EXTEND – BUS ZONE

Valencia Street, west side, from 60 feet to 81 feet south of 25th Street (removes general parking meter #1408)

 \Rightarrow Item will be forwarded to SFMTA Board for approval and implementation.

3(b). <u>ESTABLISH – ABILITY OF PERMITTED COMMUTER SHUTTLE BUS TO USE MUNI</u> BUS ZONE

Valencia Street, west side, from 25th Street to 81 feet southerly

Item will be forwarded to City Traffic Engineer for approval and implementation.

4. <u>ESTABLISH – RESIDENTIAL PERMIT PARKING AREA N ELIGIBILITY</u> Geary Boulevard, south side, between 10th Avenue and 11th Avenue (4600 block)

 \Rightarrow Item will be forwarded to SFMTA Board for approval and implementation.

5(a). ESTABLISH – TOW AWAY NO STOPPING ANYTIME

O'Farrell Street, north side, from Franklin Street to 29 feet easterly (painted safety zone, removing general meter #1036)

O'Farrell Street, south side, from Franklin Street to 27 feet easterly (painted safety zone, removing general meter #1035)

☐ Item will be forwarded to SFMTA Board for approval and implementation.

5(b). ESTABLISH - RED ZONE

Franklin Street, west side, from Starr King Way to 20 feet southerly (daylighting, unmetered, lengthening existing red zone)

 \Rightarrow Item will be forwarded to City Traffic Engineer for approval and implementation.

6(a). ESTABLISH – TOW AWAY NO STOPPING ANYTIME

- A. Pine Street, north side, from Franklin Street to 22 feet westerly (painted safety zone, lengthening existing red zone, effectively removing one parking space)
- B. Franklin Street, east side, from Pine Street to 21 feet northerly (painted safety zone, removing one unmetered space)
- C. Pine Street, north side, from Franklin Street to 22 feet easterly (painted safety zone, lengthening existing 20' red zone currently covered by construction)

6(b). ESTABLISH - RED ZONE

Franklin Street, west side, from Pine Street to 28 feet southerly (daylighting, removing one yellow metered space #1527)

Pine Street, south side, from Franklin Street, to 26 feet easterly (daylighting, removing one general metered space #1643)

 \Rightarrow Items will be forwarded to SFMTA Board for approval and implementation.

7(a). ESTABLISH – TOW-AWAY NO STOPPING ANYTIME

Bush Street, north side, from Franklin Street to 21 feet westerly (painted safety zone, unmetered)

Franklin Street, east side, from Bush Street to 21 feet northerly (painted safety zone, removing one general metered space #1502)

7(b). ESTABLISH – RED ZONE

Franklin Street, east side, from Bush Street to 24 feet southerly (daylighting, removing one general metered space #1430)

Bush Street, south side, from Franklin Street to 20 feet westerly (daylighting, unmetered driveway)

First item will be forwarded to SFMTA Board for approval and implementation; second item will be forwarded to City Traffic Engineer for approval and implementation.

7(c). ESTABLISH - NO TURN ON RED, 7 AM TO 7 PM, EVERYDAY

Bush Street, eastbound, at Franklin Street

Item will be forwarded to SFMTA Board for approval and implementation.

8. <u>ESTABLISH – SPEED HUMPS</u>

15th Avenue, between Clement Street and Geary Boulevard

Item will be forwarded to City Traffic Engineer for approval and implementation.

9(a). <u>ESTABLISH – RESIDENTIAL PERMIT PARKING, AREA U, 1-HOUR PARKING, 8 AM</u> <u>TO 10 PM, MONDAY THROUGH SUNDAY</u>

Guy Place, south side, from 1st Street to 230 feet westerly

9(b). <u>ESTABLISH – TOW-AWAY, NO PARKING ANYTIME</u> <u>RESCIND – RESIDENTIAL PERMIT PARKING. AREA U, 1-HOUR PARKING 8 AM TO</u> <u>10 PM, MONDAY THROUGH SUNDAY</u>

Guy Place, north side, between 1st Street and Lansing Street (Residents will maintain eligibility to purchase residential parking permits)

 \implies Items will be forwarded to SFMTA Board for approval and implementation.

10. <u>ESTABLISH – NO TURN ON RED, 7 AM TO 7 PM, MONDAY THROUGH FRIDAY</u> Howard Street, westbound, at Main Street

 \implies Item will be forwarded to SFMTA Board for approval and implementation.

- EXTEND PART-TIME BUS ZONE, 3 PM TO 7 PM, MONDAY THROUGH FRIDAY Battery Street, west side, from Pine Street to 87 feet southerly (extends bus zone hours to 5 AM - 7PM)
 - \Rightarrow Item will be forwarded to SFMTA Board for approval and implementation.

46th Avenue, east side, from Santiago Street to 12 feet southerly 46th Avenue, west side, from Santiago Street to 27 feet northerly

First item will be forwarded to City Traffic Engineer for approval and implementation; Second item will be forwarded to SFMTA Board for approval and implementation.

13. ESTABLISH – RED ZONE

Balboa Street, north side, from 33rd Avenue to 28 feet easterly Balboa Street, south side, from 33rd Avenue to 22 feet westerly (removes parking meter 321-3201)

 \implies Items will be forwarded to SFMTA Board for approval and implementation.

14(a). ESTABLISH – STOP SIGN

Belvedere Street, southbound, at Carmel Street, stopping the stem of this "T" intersection

Carmel Street, north side, from Belvedere Street to 20 feet westerly

15(a). ESTABLISH – TOW-AWAY, NO PARKING ANYTIME

Eddy Street, north side, from Jones Street to 132 feet easterly (removes 2 metered motorcycle and 4 general metered parking spaces)

15(b). <u>ESTABLISH – PART-TIME PASSENGER LOADING ZONE, 9 AM TO 7 PM, DAILY</u> <u>ESTABLISH – TOW-AWAY, NO PARKING ALL OTHER TIMES</u>

Eddy Street, north side, from 132 feet to 220 feet east of Jones Street (removes 4 general metered parking spaces)

16(a). ESTABLISH – TOW-AWAY NO STOPPING ANYTIME

ESTABLISH – TRANSIT ISLAND (10-FOOT WIDE)

McAllister Street, south side, from Van Ness Avenue to 140 feet easterly

16(b). ESTABLISH – 45 DEGREE BACK-IN ANGLE PARKING

McAllister Street, south side, from Polk Street to 234 feet westerly

- E. Brannan Street, north side, between 9th Street and 10th Street/Division Street/Potrero Avenue
- F. Brannan Street, south side, between 9th Street and 10th Street/Division Street/Potrero Avenue

18. <u>ESTABLISH – ABILITY OF PERMITTED COMMUTER SHUTTLE BUS TO USE MUNI</u> <u>BUS ZONE</u>

Monterey Boulevard, north side, from Acadia Street to 75 feet westerly Polk Street, west side, from O'Farrell Street to 75 feet northerly

First item continued; second item will be forwarded to City Traffic Engineer for approval and implementation.

- 19. <u>ESTABLISH TOW-AWAY NO STOPPING ANYTIME</u> <u>ESTABLISH – TRANSIT BULB (6-FOOT WIDE)</u> McAllister Street, north side, from Van Ness Avenue to 153 feet westerly (rescinds metered space #514)
- \implies Items will be forwarded to SFMTA Board for approval and implementation.

20(a). <u>ESTABLISH – BLUE ZONE</u>

- A. 12th Street, west side, from 3 feet to 12 feet south of Market Street (converts metered space #2)
- B. Fell Street, north side, from 20 feet to 41 feet west of Van Ness Avenue (converts metered space #6)
- C. Golden Gate Avenue, south side, from Van Ness Avenue to 18 feet easterly (motorcycle spaces shifted east)
- D. Eddy Street, north side, from 5 feet to 27 feet west of Van Ness Avenue (converts metered space #802-G)
- E. Hemlock Street, south side, from 5 feet to 25 feet east of Van Ness Avenue (converts metered space #139)
- F. Broadway, north side, from Van Ness Avenue to 18 feet westerly

20(b). ESTABLISH – PASSENGER LOADING ZONE AT ALL TIMES

Van Ness, west side, from 114 feet to 152 feet south of McAllister Street (shifts existing white zone 10 feet north to accommodate a new curb ramp for the existing blue zone)

Item will be forwarded to City Traffic Engineer for approval and implementation.

20(c). <u>ESTABLISH – YELLOW METERED LOADING ZONE, 30-MINUTE TIME LIMIT, 7 AM</u> <u>TO 6 PM, MONDAY THROUGH FRIDAY</u>

Van Ness Avenue, east side, from 30 feet to 70 feet north of McAllister Street (shifts existing yellow zones northward due to corner sidewalk widening)

Item will be forwarded to City Traffic Engineer for approval and implementation.

20(d). ESTABLISH – 30-MINUTE GREEN METER, 9 AM TO 6 PM, MONDAY THROUGH SATURDAY

Eddy Street, north side, from 49 feet to 71 feet west of Van Ness Avenue (converts metered space #806 to a green zone)

 \Rightarrow Item will be forwarded to City Traffic Engineer for approval and implementation.

20(e). ESTABLISH – METERED MOTORCYCLE PARKING

Golden Gate Avenue, south side, from 18 feet to 28 feet east of Van Ness Avenue (due to shift of metered space #541 to the corner and conversion to a blue zone)

 \Rightarrow Item will be forwarded to City Traffic Engineer for approval and implementation.
