## April 1, 2016 PUBLIC HEARING RESULTS

The Sustainable Streets Division of the San Francisco Municipal Transportation Agency held a public hearing on Friday, April 1, 2016, at 10:00 AM, in Room 416 (Hearing Room 4), City Hall, 1 Dr. Carlton B. Goodlett Place, San Francisco, CA 94102, to consider the proposals listed below. This document summarizes the results of the hearing. Per Section 201 of the City Transportation Code, some items can be implemented by the authority of the City Traffic Engineer. Other items require further approval by the SFMTA Board.

#### 1. ESTABLISH - SPEED CUSHIONS

Clayton Street, between Ashbury Street and Parnassus Street (2 Speed Cushions)

Item will be forwarded to the City Traffic Engineer for approval and implementation.

### 2. ESTABLISH - SPEED CUSHIONS

Ashbury Street, between Clayton Street and Piedmont Street (2 Speed Cushions) Ashbury Street, between Piedmont Street and Frederick Street (2 Speed Cushions)

 $\implies$  Items will be forwarded to the City Traffic Engineer for approval and implementation.

### 3. ESTABLISH – METERED MOTORCYCLE PARKING

22<sup>nd</sup> Street, north side, from 93 feet to 103 feet east of Valencia Street (2 motorcycle spaces next to newly constructed active driveway)

Item will be forwarded to the City Traffic Engineer for approval and implementation.

### 4. ESTABLISH – UNMETERED MOTORCYCLE PARKING

7<sup>th</sup> Street, west side, from 10.5 feet to 53 feet north of King Street (11 Unmetered Motorcycle Stalls at 3.5 feet wide)

Item will be forwarded to the City Traffic Engineer for approval and implementation.

### 5. ESTABLISH – STOP SIGNS

Noriega Street, eastbound and westbound, at 20<sup>th</sup> Avenue, making this intersection an allway STOP

Item will be forwarded to SFMTA Board for approval and implementation.

### 6. ESTABLISH – STOP SIGN

Linden Street, eastbound, at Gough Street
