PURPOSE

To approve various routine traffic and parking modifications.

GOAL

This action supports the following SFMTA Strategic Plan Goal and Objectives:

- D. ESTABLISH PARKING METER AREA 3 22nd Street, south side, between San Jose Avenue and Valencia Street. **PH 10/19/12 Requested by SFMTA.**
- E. ESTABLISH STOP SIGN Stopping Walter U. Lum Place, southbound, at Clay Street The stem of this T-intersection. **PH 10/19/12 Requested by Residents.**
- F. ESTABLISH PERPENDICULAR PARKING Greenwich Street, both sides, from 170 feet to 250 feet east of Hyde Street. **PH 10/19/12 Requested by Residents.**
- G. ESTABLISH NO PARKING ANYTIME Harold Avenue, east side, from 281 feet to 305 feet south of Grafton Avenue (24-foot zone across from 25 and 29 Harold Avenue). PH 10/19/12 Requested by Resident.
- H. ESTABLISH PARK AT 90 DEGREES Harold Avenue, east side, from 305 feet to 358 feet south of Grafton Avenue (53-foot zone across from 19 and 21 Harold Avenue). PH 10/19/12 Requested by Resident.
- I. ESTABLISH NO PARKING VEHICLES OVER 6 FEET TALL Keith Street, both sides, between Wallace Avenue and Yosemite Avenue. **PH 10/19/12 Requested by Business.**
- J. ESTABLISH TOW-AWAY NO STOPPING MIDNIGHT TO 5 AM EVERYDAY Florida Street, both sides, from 16th Street to Treat Street; and Florida Street, east side, from 16th Street to 17th Street. PH 10/19/12 Requested by Business.
- K. ESTABLISH STOP SIGNS Stopping eastbound and westbound Rivera Street at 40th Avenue, making this intersection an All-Way STOP. **PH 10/19/12 Requested by Residents.**

WHEREAS, The San Francisco Municipal Transportation Agency has received a request, or identified a need for traffic modifications as follows:

- A. ESTABLISH RED ZONE Taraval Street, north side, from 5 feet to 25 feet east of 27th Avenue; Taraval Street, south side, from 5 feet to 27 feet west of 27th Avenue; and Taraval Street, north side, from 5 feet to 23 feet east of 25th Avenue.
- B. ESTABLISH RIGHT LANE MUST TURN RIGHT EXCEPT BUSES AND BICYCLES Northbound Bayshore Boulevard, from Helena Street to Marengo Street.
- C. ESTABLISH NO PARKING ANYTIME Gough Street, west side, at Clay Street, between the northern and southern crosswalks.
- D. ESTABLISH PARKING METER AREA 3 22nd Street, south side, between San Jose Avenue and Valencia Street.
- E. ESTABLISH STOP SIGN Stopping Walter U. Lum Place, southbound, at Clay Street The stem of this T-intersection.
- F. ESTABLISH PERPENDICULAR PARKING Greenwich Street, both sides, from 170 feet to 250 feet east of Hyde Street.
- G. ESTABLISH NO PARKING ANYTIME Harold Avenue, east side, from 281 feet to 305 feet south of Grafton Avenue.
- H. ESTABLISH PARK AT 90 DEGREES Harold Avenue, east side, from 305 feet to 358 feet south of Grafton Avenue.
- I. ESTABLISH NO PARKING VEHICLES OVER 6 FEET TALL Keith Street, both sides, between Wallace Avenue and Yosemite Avenue.
- J. ESTABLISH TOW-AWAY NO STOPPING MIDNIGHT TO 5 AM EVERYDAY Florida Street, both sides, from 16th Street to Treat Street; and Florida Street, east side, from 16th Street to 17th Street.
- K. ESTABLISH STOP SIGNS Stopping eastbound and westbound Rivera Street at 40th Avenue, making this intersection an All-Way STOP.
- L. ESTABLISH RIGHT TURN $ONLY 9^{th}$ Avenue, northbound and southbound, at California Street.
- M. ESTABLISH BLUE ZONE 256 Rose Street, north side, from approximately 0 feet to 26 feet west of the east property line.
- N. ESTABLISH RED ZONE Mission Street, west side, at Rolph Street from five feet to 27 feet northerly.

WHEREAS, The public has been notified about the proposed modifications and has been given the opportunity to comment on those modifications through the public hearing process; now, therefore, be it

RESOLVED, That the San Francisco Municipal Transportation Agency Board of Directors, upon recommendation of the Director of Transportation and the Director of the Sustainable Streets Division does hereby approve the changes.
