ORDER OF BUSINESS

1. Call to Order

Vice Chairman Brinkman called the meeting to order at 1:05 p.m.

3. Announcement of prohibition of sound producing devices during the meeting.

Vice Chairman Brinkman announced that the ringing of and use of cell phones, pagers and similar sound-producing electronic devices are prohibited at the meeting. She advised that any person responsible for the ringing or use of a cell phone, pager, or other similar sound-producing electronic devices might be removed from the meeting. She also advised that cell phones that are set on "vibrate" cause microphone interference and requested that they be placed in the "off" position.

Board Secretary Boomer announced that there would be no discussion of anticipated litigation in closed session.

Vice Chairman Brinkman requested an update on what the SF Bicycle Coalition is doing with respect to cycling, street safety and civility at the August meeting and in September, for the Board to have the opportunity to have a fuller discussion regarding these efforts.

Director Reiskin presented special recognition awards to Kerstin Fraser Magary, Senior Manager; Ken Yee, Manager of Real Estate and Property Management; Jason Gallegos - Manager of Real Estate Development; Jay De Los Reyes, Principal Administrative Analyst/TIDF Administrator; Bose Onyemem, Principal Administrative Analyst; Charles Lewis, Principal Information System Business Analyst; Steven Corbin, Transit Supervisor, Flynn Division and Johnnie Waller III, transit operator, Kirkland Division, Transit Services.

In addition to the topics listed above, Director Reiskin also discussed the stroller policy.

PUBLIC COMMENT:

Tone Lee suggested that the bond money should be spent to help cab drivers who face threats from the market and from the street. He also expressed appreciation for the work done on Duboce Street.

Mark Gruberg expressed appreciation for returning taxis to their own division under the director and expressed hope that Ms. Hayashi will continue as the Director.

8. Citizens' Advisory Council Report

Daniel Murphy, chairman, Citizen's Advisory Council, presented the report.

Chairman Nolan arrived.

PUBLIC COMMENT:

Tone Lee stated that CAC forgot to mention that too many bicycle lanes are being installed.

9. Public Comment

Hansu Kim discussed how difficult it is for Desoto, Luxor and Yellow cab companies to stay in business. If they don't get support they will have to change their business and move into the sedan service. Ubercab and limousine companies are taking over the industry.

Herbert Weiner welcomed Director Rubke and thanked Director Brinkman for walking her bike on the sidewalk. He asked if the Board had received his letter and why information panels hadn't been installed at every bus stop. He wondered if the density of traffic could be evaluated; what happens to the money if a bus doesn't arrive and about on-time performance reporting.

Tone Lee discussed single operator permits and hours of driving which impact driver income.

Jeet Ghotra discussed taxi medallions; how limousines and sedans are ruining the cab industry and how bicyclists should ride on the road.

Barry Taranto expressed appreciation regarding the recent reorganization and expressed hope that the Taxi Division will be fully staffed. He suggested that Ubercab address the Board regarding what they're doing and that the attorneys should look at the legality of what Ubercab is doing. He also discussed the increase in hours for the single operator permits and the lack of information for town hall meetings.

Brian Rosen discussed the taxi medallion list and the lack of medical insurance for most cab drivers.

Bill Mounsey discussed his impression that the Board is not taking care of the cab business. Corruption is out of control because of Ubercab and limousines on the street. The taxicab industry will go out of business if this continues.

Keith Dennis discussed the 89 Laguna Honda line and asked that it be restored.

Mary McGuire discussed offensive bus shelter ads that say that cat lovers and crazy aunts deserve to die. She also discussed Ubercab and asked about integrated dispatch.

Mark Gruberg discussed credit card fees; the elimination of credit card fees to drivers in New York City and the secret decision to use spare cabs. He urged action regarding Ubercab.

Emil Lawrence asked when the SFMTA was going to stop squeezing taxi drivers and discussed how no attention is paid to his input.

Barry Korengold discussed single operator permit, the medallion wait list and how Luxor, Desoto and Yellow cab make money.

Gagandip Singh discussed taxicab service in San Francisco; limousines and Bay City cab company.

Chairman Nolan requested information about the impact of Ubercab and limousine companies on the taxi industry and about credit card charges.
