- Categorically exempt from Environmental Review Class 1(c)(9) changes in the traffic and parking regulations where such changes do not establish a higher speed limit and/or result in more than a negligible increase in the use of the street and/or Class 1(c)(13) installation, modification and replacement of traffic signals, where no more than a negligible increase in the use of the street will result.

- F. ESTABLISH BLUE ZONE 17th Street, north side, from Hampshire Street to 18 feet westerly (18-foot zone).
- G. ESTABLISH TOW-AWAY, NO STOPPING ANYTIME 17th Street, north side, from 132 to 172 feet west of Hampshire Street (40-foot zone).
- H. RESCIND TOW AWAY NO STOPPING ANYTIME Grove Street, south side, from 24 feet to 32 feet east of Gough Street; Gough Street, east side, from 24 feet to 36 feet south of Grove Street; Gough Street, east side, from 24 feet to 26 feet north of Hayes Street; and Gough Street, west side, from 25 feet to 26 feet south of Fell Street.
- I. ESTABLISH TOW AWAY NO STOPPING ANYTIME Hayes Street, north side, from 21 feet to 25 feet east of Gough Street.
