Hello Angelina,

Thanks for getting back to me on Wednesday. Nice to connect in these bizarre circumstances. Here are follow-up items we discussed.

First, Here are the two stations ready for deployment in D1.

-34th Ave at Balboa

-21st Ave at Geary

SFMTA permitted both of these following full legislation. Bay Wheels will get construction permits, which puts our targeted timeline in about two weeks, approximately May 20. We'll update you as that timeline is solidified.

Second, here are talking points on why Bikeshare is an essential service.

- With prolonged Shelter in Place, the Bikeshare Program is receiving direction to further expand bikeshare operations as an essential service, especially in light of reduced Muni service.
- SF and other cities with bikeshare are hearing that users prefer to ride bikeshare over enclosed vehicles like transit or rideshare.
- Earlier, the stationless bikeshare service area expanded to almost the entire city; we're looking to support this with more stations, which provide more regular, affordable and accessible, service.
- For now, the SFMTA isn't permitting new stations, but we are hoping to advance with construction for a handful of already-permitted sites.

Third, here's a link describing **Bay Wheels's COVID-19 measures** to minimize transmission within the system.

Finally, with regard to stations and encampments next to stations, Bikeshare is looking to establish **a standard 15' buffer** to maintain distancing for service staff. At the moment, some encampments are directly next to stations, which creates health issues for workers, residents and users. This buffer would be akin to ensuring boarding islands and bus waiting zones are also open. SFMTA is reaching out to our

contacts in PD, but any assistance the supervisor can provide to help get better traction is much appreciated. I believe there are two or three stations out of service because of this right now.

Additionally, to always keep things on your radar, there are **three D1 stations in development.** We don't have a clear legislation path at the moment since we've frozen Engineering Public Hearings at City Hall. However, there are efforts to establish an alternate potentially virtual venue, which means permits could begin to flow again, and installations could take place at the end of May or June. Of course, we will continue with our vigilant outreach with mailers to everyone near stations, along with the full revised public hearing notification practice. If you have any input/questions about these, let us know.

- 38th Ave at Balboa ready for SFMTA Public Hearing.

Hi Darren,

Thank you for your feedback, that's great to hear! Yes of course, it's a little vague to me what information you would like on placement. Generally most of our bikeshare stations are typically on SFMTA right of way and installation takes 2-3 hours where nothing is bolted to the ground. If the bikeshare station converts parking spaces, we add bollards around the station. I can send you a site plan of a similar station size to the one we're proposing at La Playa at Balboa if that would be helpful.

PROJECT DESCRIPTION:

The San Francisco Municipal Transportation Agency (SFMTA) proposes to implement a city-wide bicycle sharing system in San Francisco as part of the regional Bay Area Bicycle Share (BABS) system described in detail below. The current regional bicycle share system in San Francisco is a pilot project managed by the Bay Area Air Quality Management District (BAAQMD). The regional BABS system will transfer to the Metropolitan Transportation Commission (MTC) for program oversight at the end of 2015. As part of a BABS pilot project initiated on August 29, 2013, the system operator installed approximately 35 bicycle share stations with input from the SFMTA, comprising 350 bicycles within the public right-of-way, located generally in the northeast section of the City. The proposed project would maintain and upgrade the existing 35 pilot bicycle share stations, and expand the BABS system within San Francisco to comprise a total of approximately 450 stations and 4,500 bicycles across the City and County of San Francisco (San Francisco).

DETERMINATION:

The City and County of San Francisco decided to carry out or approve the project on December 18, 2015. The San Francisco Board of Supervisors (BOS) approved a coordination agreement with the Metropolitan Transportation Commission (MTC), other local partners in the East and South Bay, and the bicycle share operator to carry out the Bay Area Bicycle Share Program, which would be overseen in San Francisco by the San Francisco Municipal Transportation Agency (SFMTA) on December 8, 2015. The agreement was provided to Mayor Lee for his signature and becomes effective upon signing or when ten days have passed. This project in its approved form has been determined to be exempt from environmental review because it would result in the installation of up to 450 bicycle sharing stations throughout San Francisco, primarily within the public right-of-way and on some parcels. The proposed individual stations are portable, modular, and would be solar and battery powered, and would thus not involve excavation or utility connections. The bicycle sharing station equipment is small in scale and massing relative to surrounding buildings or sites. Bicycle facilities and infrastructure are common sights within the urban environment. There would be no potential for significant environmental impacts at either a project or cumulative level. Therefore, the proposed project would be exempt from environmental review under Class 3.
