

SAN FRANCISCO MUNICIPAL TRANSPORTATION AGENCY Order # 6547 FOR PUBLIC HEARING

The Streets Division of the San Francisco Municipal Transportation Agency will hold a virtual public hearing starting on Monday, June 13, 2022 at 9:30 AM through Friday, June 24, 2022 at 11:30 PM to consider the matters listed on the agenda below. The event is virtual and can be accessed via the project webpage at SFMTA.com/LakeSlowStreet.

The purpose of the public hearing will be to get public feedback on the Lake Street Draft Design, which is subject to refinement based on public feedback and interagency review. *No decisions will be made on these items during the public hearing.* Based on all public feedback received, the SFMTA will make and post the decision on these items by 5.pm. two weeks after the Engineering Public Hearing concludes on the project webpage.

The following items have been environmentally cleared by the Planning Department on July 21, 2021, (Case 2021-007227ENV):

Lake Street, between Arguello Boulevard and 25th Avenue – Lake Street Project

1. ESTABLISH – DO NOT ENTER EXCEPT BIKES

Lake Street at 24th Avenue, eastbound Lake Street at 14th Avenue, westbound Lake Street at Funston, eastbound Lake Street at 2nd Avenue, westbound

ESTABLISH – STOP SIGN

Lake Street, eastbound and westbound, at 24th Avenue Lake Street, eastbound and westbound, at 21st Avenue Lake Street, eastbound and westbound, at 17th Avenue Lake Street, eastbound and westbound, at 10th Avenue Lake Street, eastbound and westbound, at 8th Avenue Lake Street, eastbound and westbound, at 8th Avenue

ESTABLISH – RAISED CROSSWALK

Lake Street at 15th Ave, east crosswalk Lake Street at 12th Avenue, west crosswalk Lake Street at 10th Avenue, west crosswalk

ESTABLISH - SPEED CUSHIONS

Lake Street from 15th Avenue to 14th Avenue (1 3-lump cushion) Lake Street from Funston Avenue to 12th Avenue (1 3-lump cushion) Lake Street from 3rd Avenue to 2nd Avenue (1 3-lump cushion) 2nd Avenue from California to Lake Street (1 3-lump cushion)

(Supervisor District 1)

This proposal implements design features that will maintain lower traffic volumes and speeds on Lake Street, while still accommodating local access needs.

California Environmental Quality Act (CEQA) Appeal Rights under Chapter 31 of the San Francisco Administrative Code: For Approval Actions, the Planning Department has issued a CEQA exemption determination or negative declaration, which may be viewed online at http://www.sf-planning.org/index.aspx?page=3447. Following approval of the item by the SFMTA City Traffic Engineer, the CEQA determination is subject to appeal within the time frame specified in S.F. Administrative Code Section 31.16, typically within 30 calendar days of the Approval Action. For information on filing a CEQA appeal, contact the Clerk of the Board of Supervisors at City Hall, 1 Dr. Carlton B. Goodlett Place, Room 244, San Francisco, CA 94102, or call (415) 554-5184. Under CEQA, in a later court challenge, a litigant may be limited to raising only those issues previously raised at a hearing on the project or in written correspondence delivered to the Board of Supervisors or other City board, commission or department at, or prior to, such hearing, or as part of the appeal hearing process on the CEQA decision.

Whether the City Traffic Engineer's decision is considered a Final SFMTA Decision is determined by Division II, Section 203 of the Transportation Code. If the City Traffic Engineer approves a parking or traffic modification, this decision is considered a Final SFMTA Decision. If a City Traffic Engineer disapproves a parking or traffic modification and a member of the public requests SFMTA review of that decision, the additional review shall be conducted pursuant to Division II, Section 203 of the Transportation Code. City Traffic Engineer decisions will be posted on <u>SFMTA.com/EngineeringResults</u> by 5 p.m. on the Wednesday following the public hearing. Final SFMTA Decisions involving certain parking or traffic modifications, whether made by the City Traffic Engineer or the SFMTA Board, can be reviewed by the Board of Supervisors pursuant to <u>Ordinance 127-18</u>. Draft design. Subject to refinement based on public feedback and interagency review. The Lake Street project draft design proposes to install traffic calming elements to maintain Lake Street as a safe and comfortable active transportation corridor. The draft design focuses on clear guidelines around street usage, and maintenance of lower traffic volumes and speeds between 29th Avenue and Arguello Boulevard. Draft design elements include:

- Traffic diverters at 4 locations at 2nd Ave, Funston, 14th Ave, and 24th Ave. Each diverter would prohibit through traffic in one direction only.
- Six new all way stops (3rd, 8th, 11th, 17th, 21st and 24th Avenues) to ensure that vehicles on Lake Street must stop every two blocks, at most.
- Eight new traffic calming elements spaced along the corridor (speed cushions and raised crosswalks) to decrease cutthrough traffic.

Pending project approvals, implementation could begin as early as July 2022.
