FOR PUBLIC HEARING

The Sustainable Streets Division of the San Francisco Municipal Transportation Agency will hold a public hearing on Friday, October 25, 2013 at 10:00 AM, in Room 416 (Hearing Room 4), City Hall, 1 Dr. Carlton B. Goodlett Place, San Francisco, CA 94102, to consider the following proposals:

ESTABLISH – SIX-WHEEL TRUCK LOADING ZONE, 9AM TO 4PM, MONDAY THROUGH FRIDAY

1335 Pacific Avenue, south side, from 2 feet to 51 feet east of driveway (49-foot zone)

<u>REVOKE – PART-TIME PASSENGER LOADING ZONE, 8AM TO 6PM, MONDAY</u> <u>THROUGH FRIDAY</u>

899 Tennessee Street, east side, from 14 feet to 54 feet north of 20th Street (40-foot zone)

ESTABLISH – PART-TIME PASSENGER LOADING ZONE, 8AM TO 6PM, MONDAY THROUGH FRIDAY

899 Tennessee Street, east side, from 14 feet to 98 feet north of 20th Street (84-foot zone) (contingent upon raising non-functional driveway near north end of property where modular classrooms are located)

ESTABLISH – GREEN ZONE, 9AM TO 6PM, MONDAY THROUGH SATURDAY

"198" Balboa Street, north side, from 2 feet to 20 feet east of 3rd Avenue (18-foot zone)

<u>REVOKE – YELLOW ZONE</u> <u>ESTABLISH – PART-TIME PASSENGER LOADING ZONE, 8AM TO 5PM, MONDAY</u> <u>THROUGH SATURDAY</u>

"699" Chestnut Street, south side, from 0 feet to 20 feet east of Columbus Avenue (20-foot zone)

ESTABLISH – GREEN ZONE, 9AM TO 6PM, MONDAY THROUGH SATURDAY

2600 40th Avenue, east side, from 0 feet to 38 feet south of crosswalk line (38-foot zone)

ESTABLISH – YELLOW ZONE, 8AM TO 6PM, MONDAY THROUGH SATURDAY

"1525" Armstrong Avenue, south side, 2 feet to 50 feet west of the east driveway (48-foot zone)

ESTABLISH - GREEN ZONE, 9AM TO 6PM, MONDAY THROUGH SATURDAY

2084 Hayes Street, north side, from 0 feet to 20 feet east of Cole Street (20-foot zone)

ESTABLISH - BLUE ZONE

400 Florida Street, west side, from 0 feet to 20 feet south of 17th Street (20-foot zone)

ESTABLISH – PART-TIME ACCESSIBLE PASSENGER LOADING ZONE (SUNRISE TO SUNSET, DAILY)

2101 Washington Street, south side, from 28 feet to 62 feet west of Octavia Street (34-foot zone)

ESTABLISH – NO PARKING, PART-TIME PASSENGER LOADING ZONE, 2:30PM TO 4:30PM, SCHOOL DAYS AND DURING POSTED SERVICES

1801 Octavia Street, west side, from 0 feet to 66 feet north of Pine Street (66-foot zone, extends white zone operation beyond current "posted services" regulations)

ESTABLISH - PART-TIME PASSENGER LOADING ZONE, 7AM TO 10PM, DAIILY

1340-60 Lombard Street, north side, from 70 feet to 88 feet east of the west property line (18-foot zone)

REVOKE – YELLOW ZONE

557 Waller Street, south side, from 3 feet to 25 feet west of Potomac Street (22-foot zone)

Public hearings are held once a month at City Hall to legislate the installation of new colored zones. The zones usually recommended for this process are blue, green, white, and yellow. The purpose of the hearing is for residents to express their concerns regarding proposed changes affecting their streets. All interested parties are encouraged to attend. At the Public Hearing, the Hearing Officer will review the items and listen to residents, then make a final decision. Upon approval and payment of any applicable installation fees, zones will be installed as soon as scheduling permits.
