## ORDER OF BUSINESS

### 1. Call to Order

Chairman Nolan called the meeting to order at 1:03 p.m.

### 2. Roll Call

### 3. Announcement of prohibition of sound producing devices during the meeting.

Chairman Nolan announced that the ringing of and use of cell phones, pagers and similar sound-producing electronic devices are prohibited at the meeting. He advised that any person responsible for the ringing or use of a cell phone, pager, or other similar sound-producing electronic devices might be removed from the meeting. He also advised that cell phones that are set on “vibrate” cause microphone interference and requested that they be placed in the “off” position.

### 4. Approval of Minutes

Ed Reiskin, Director of Transportation recognized Joyce Furlough, Executive Secretary, Taxi and Accessible Services Division.

Director Reiskin also discussed recognition for employees for their years of service; recognition by the American Public Transportation Association for the SFMTA's commitment to sustainability; legislation approved by Governor Brown; long-range transportation planning; upcoming Central Subway work; and a raised bike lane on Market Street.

#### 9. Public Comment

Anthony Ballester asked for a moment of silence for Mark Currier. His thoughts and prayers are with his family. He has been in contact with the operator involved who also sends his thoughts and prayers. Safety is important.

Mark Gleason discussed the "labor harmony" ordinance approved by the Board of Supervisors for the drivers of commuter shuttle buses. The acrimony is not something that Teamsters look forward to. The subsidy that comes with the low fare box recovery is coming out of the wallets of the shuttle bus drivers. Those drivers are making substandard wages. Until something is done, the issue will continue at Muni bus stops.

Herbert Weiner stated that there's a horror story every day on Muni. Muni isn't about service for all. Seniors and people with disabilities are forced to walk long distances to get to a bus stop. More buses should have been added to the most frequently used routes, but instead millions have been spent on public relations.

Cathy DeLuca urged the City to make the intersection of Kearny and Clay safe for pedestrians by installing a pedestrian scramble. The community is asking for this scramble. WalkSF has received 260 signatures on a petition. She discussed a recent fatality at that intersection. Kearny is a high injury corridor. Seven people in the past five years were seriously injured at this intersection. The SFMTA needs to do something now. The public can't wait for future improvements or for another person to get killed.

Ed Healy congratulated the Board for "Safer Market Street." Transportation Network Companies (TNCs) are opening bus lines, such as "Uber Pool" and "Lyft Line" and stating that these buses will reduce congestion. These vehicles have no emission controls and are targeting every bus line in the city. The SFMTA can control the fact that they're using bus stops. TNC's are targeting bus riders which will undermine Muni service.

Gum Gee Lee asked for the intersection at Kearny and Clay to be made safe. He urged the SFMTA to improve pedestrian safety and implement a pedestrian scramble at that intersection immediately. Chinatown is one of the densest neighborhoods and thousands of people cross that intersection to get to the park. This puts the lives of seniors at risk. He doesn't want to worry about the safety of his family.

James Wong urged the Board to approve the scramble system at Clay and Kearny. Kearny is a very busy street and seniors are very concerned about crossing that street. Seniors go to Portsmouth Square every day and are concerned about the traffic. The Central Subway Project will bring more visitors to the area. Seniors want to age in a place where they don't want have to worry about safety while walking.

Phil Chin stated that Chinatown TRIP supports a pedestrian scramble and a queuing system at the Portsmouth Square garage. The SFMTA has expressed concern that Muni would be delayed but a pedestrian scramble will not take away from Muni service.

Angelina Yu stated that the intersection at Kearny and Clay is really dangerous. Streets can be made safer by design. A left turning vehicle killed a pedestrian at that intersection. This is a dense, congested intersection and elders should be prioritized.

Rosa Chen stated that Chinatown has changed a lot in the past twenty years. She wants to see the scramble system installed at Kearny and Clay. The one installed on Stockton has saved many lives. This should be prioritized. She has collected many signatures from people who support a scramble system including not only residents but visitors as well.

Diana Lim stated that her grandparents live in Chinatown. Walking is their primary mode of transit. A large concentration of seniors cross at Kearny and Clay and many who come from Visitation Valley get off there. The SFMTA should make changes before there is another incident.

Malcolm Yeung praised the Board for launching the long term transportation planning effort. He also discussed the scramble system at Kearny and Clay. There have been seven deaths in the last five years which is unacceptable. Now the community is hearing excuses. The SFMTA can do better. At Sacramento, the SFMTA installed a change within a few months. The community wants to see the same action at Kearny and Clay. He wants the SFMTA to respond quickly.

Shirley Tsang urged the Board to implement a scramble system at Kearny and Clay immediately. Drivers speed along that street and they don't yield to pedestrians. Chinatown residents are concerned about their safety when they cross the street. She asked the Board to ensure safety for the community.

Peter Lee discussed the changes along the Kearny Street corridor over the last few years. There's a college, hotel and childcare services in the area. The foot traffic in this corridor is very heavy. He expressed support for a pedestrian scramble as it will save trouble and prevent accidents. It should be installed as soon as possible.

Christopher Fulkerson stated that the automated waybill system has exceeded the worst case scenario of inaccuracy. It needs attention. He presented a petition signed by 498 people. The system is completely dysfunctional. He got a waybill that said he made \$30,000 in one shift. If that was reported to Internal Revenue Service, it would create problems. He was met with hostility when he tried to correct it. The public disagrees with the SFMTA about the safety and utility of the backseat units. The public doesn't like them and it's difficult for inebriated drivers to use them.

Tone Lee stated that traffic on Mason Street is heavy given the construction in Union Square. It's overwhelming during rush hour. He suggested that parking spots be banned during rush hours to add a lane. Kearny Street is a major crosstown route that is flat. The parking lot is confusing to drivers.

Emil Lawrence stated the declining checkbook balances for taxi drivers is due to Uber drivers. Uber is wrecking taxi drivers. The SFMTA is doing nothing to enforce regulations because the Mayor told the SFMTA to lay off. This is corruption. The Mayor, the Board of Supervisors and the SFMTA don't want the police to issue tickets. The agenda is full of zones, not one of them is for taxis.

Rose Chung stated that the Portsmouth Square garage plays a significant role in the community and if a lane was eliminated, it would create a problem. Giving a "red carpet treatment" for Muni is not good for pedestrians.

Norman Fong asked the Board to act quickly at the intersection of Kearny and Clay. Seniors are aging and they have to be kept safe. It costs money but it needs to be done.

Barry Korengold stated the Board isn't aware of traffic congestion and how dangerous the streets have become in the last two years since the TNC's started. The TNC's are expanding everyday but there are only 5,000 taxi drivers. TNC's are double-parking, making crazy turns and aren't familiar with city streets. San Francisco is the second most congested city in the U.S. The changes to Market Street were a great idea but there is no enforcement. TNC's need to be regulated.

Charles Rathbone discussed the ban on wrap ads and taxis that can't accommodate Superbowl ads. In a time of declining revenues, the industry could use that revenue. He asked the SFMTA to revisit wrap ads as well as credit card charges. The current limit is unrealistically low. An Uber manager says they have 30,000 drivers. This is a congestion issue that is mushrooming.

The Board requested that staff present a report about the intersection of Kearny and Clay at a future meeting.

Under CEQA, in a later court challenge, a litigant may be limited to raising only those issues previously raised at a hearing on the project or submitted in writing to the City prior to or at such hearing, or as part of the appeal hearing process on the CEQA decision.

The Ethics Commission of the City and County of San Francisco has asked us to remind individuals and entities that influence or attempt to influence local legislative or administrative action may be required by the San Francisco Lobbyist Ordinance [S.F. Campaign and Governmental Conduct Code section 2.100 et seq.] to register and report lobbying activity.
