## **BRIEF DESCRIPTION:**

#### **PURPOSE**

Approving traffic and parking modifications on Oakdale Avenue between Loomis and Selby streets to remove an eastbound travel lane, widen the existing bicycle lanes, and install painted buffers.

### **GOAL**

This action supports the following SFMTA Strategic Plan Goal and Objectives:

Goal 1- Create a safer transportation experience for everyone, and

Goal 2- Make transit, walking, bicycling, taxi, ridesharing and carsharing the preferred means of travel.

#### DESCRIPTION

This project will remove an eastbound travel lane and widen existing bicycle lanes on Oakdale Avenue between Loomis and Selby streets. Oakdale Ave. will be widened and have painted buffers installed. This project will take advantage of an upcoming paving project. Striping work will be coordinated with repaving.

The project will remove unneeded roadway capacity to improve safety and comfort for bicyclists and pedestrians. Bicyclists will have more dedicated space, and pedestrians will have one less lane of exposure while crossing the street.

On May 22, 2014, the traffic lane changes and parking modifications associated with this project were discussed at an SFMTA public hearing. There was no opposition to the project by members of the public.

As part of the road diet design, the following traffic and parking modifications are requested:

ESTABLISH – TOW-AWAY NO STOPPING ANYTIME Oakdale Avenue, south side, from 100 to 200 feet east of Loomis Street

ESTABLISH - RED ZONE

Oakdale Avenue, south side, from Industrial Street to 20 feet westerly

RESCIND – LEFT LANE MUST TURN LEFT Oakdale Avenue, eastbound, approaching Selby Street

#### ALTERNATIVES CONSIDERED

The alternative considered is not making changes. The existing conditions provide excess vehicle capacity, and do not improve bicycle and pedestrian conditions, so staff concluded that a road diet is the best way to proceed.

### **FUNDING IMPACT**

This road diet project is part of the Oakdale Prop B project, which costs \$302,000. This project is completely funded through Prop B.

## OTHER APPROVALS RECEIVED OR STILL REQUIRED

The proposed traffic modifications are subject to environmental review under the California Environmental Quality Act (CEQA). On July 17, 2014, the Planning Department determined that the proposed parking and traffic modifications are categorically exempt from environmental review under Class 1(c) (existing highways and streets, sidewalks, gutters, bicycle and pedestrian trails, and similar facilities) and Class 4(h) exemption (creation of bicycle lanes on existing rights-of-way).

A copy of the determination is on file with the Secretary for the SFMTA Board of Directors. The proposed action is the Approval Action as defined by the S. F. Administrative Code Chapter 31.

The City Attorney has reviewed this calendar item.

### RECOMMENDATION

Staff recommends that the SFMTA Board approve traffic and parking modifications on Oakdale Avenue between Loomis and Selby streets to remove an eastbound travel lane, widen the existing bicycle lanes, and install painted buffers.
