# **BRIEF DESCRIPTION:**

Designating various on-street car share parking spaces pursuant to Transportation Code Division II, Section 911.

# **SUMMARY:**

- The SFMTA Board approved a two-year on-street car share pilot program, as well as amendments to the Transportation Code on July 16, 2013. The pilot program includes qualified car share organizations (CSOs) who will be permitted exclusive and conditional use of on-street parking spaces in exchange for providing various data to evaluate the feasibility and effectiveness of on-street car sharing spaces.
- The SFMTA approved three entities as qualified CSOs for pilot program participation. These CSOs have requested 450 on-street parking spaces, and are conducting community outreach with SFMTA's oversight and coordination. Under this pilot program, a total of 900 on-street parking spaces may be designated as car share parking spaces.
- On-street car share parking spaces must be approved by the SFMTA Board of Directors as required by the Transportation Code.

Designating various on-street car share parking spaces pursuant to Transportation Code Division II, Section 911.

# **GOAL**

Goal 2: Make transit, walking, bicycling, taxi, ridesharing & carsharing the preferred means of travel

Objective 2.3: Increase use of all non-private auto modes.

Objective 2.4: Improve parking utilization and manage parking demand

# **DESCRIPTION**

Based on the experience of an initial pilot carried out by the SFMTA in 2011-2012, as well as the SFMTA's ongoing car share parking program in designated off-street parking facilities, in July 2013 the SFMTA Board adopted a car share policy framework and approved a two-year pilot program to further evaluate the feasibility and effectiveness of on-street car sharing spaces. At the conclusion of the pilot, SFMTA staff will complete an evaluation and recommend whether to make the on-street car share program permanent.

The two-year pilot program will include qualified car share organizations (CSOs) who will be permitted exclusive and conditional use of on-street parking spaces in exchange for providing various data to evaluate the feasibility and effectiveness of on-street car sharing spaces.

The SFMTA has approved three entities as qualified CSOs for pilot program participation. These CSOs have requested 450 parking spaces for designated car share vehicle parking spaces, and are conducting community outreach with SFMTA's oversight and coordination.

For each proposed car share parking location, CSOs have spoken with the fronting and proximal property owners and residential and/or business tenants in those properties, providing them with SFMTA pilot project information and project manager contact information. CSOs and SFMTA have communicated with other businesses, neighbors, and organizations in the vicinity of these spaces, and district Supervisors have been informed of the pilot proposals and process.

To date, 150 parking spaces have been designated by the SFMTA Board as exclusive on-street car share parking spaces. The proposed action would add an additional 44 on-street car share parking spaces. If approved, on-street car share vehicle parking permits will be issued for these parking spaces under the terms and conditions established for the pilot program.

#### **FUNDING IMPACT**

As many as 900 new on-street car share parking spaces may be permitted over the two year pilot program. There will be minimal revenue realized from these permits and any parking citations issued as a result of the on-street car sharing pilot program. The costs of establishing and utilizing the on-street parking spaces are to be paid by the participating CSOs.

# **PUBLIC HEARING**

Public hearings were held on June 13, 2014, July 11, 2014, July 18, 2014, and Aug 15, 2014 to consider the above parking changes; these hearings included car share location proposals not presented in this Board item. A total of 35 people provided comments about the proposals: 27 people spoke in opposition to the proposals, eight spoke in favor. In addition, 22 email messages were received from the public on the proposed parking changes: 15 voicing opposition and seven expressing support. A representative of City CarShare submitted approximately 100 emails from members expressing support for the proposals.

The chief concern voiced by opponents was the scarcity of available on-street parking in the proposed locations compounded by the large number of private vehicles owned by residents, and/or commuter or business customer vehicles, competing for limited on-street parking. Other comments expressed skepticism that car share services would be well utilized by residents, relative to the loss of scarce parking, or that private businesses would benefit from the service to the detriment of local residents.

Based on testimony from speakers at the public hearing as well as e-mail testimony submitted for the hearing, three locations comprising six parking spaces are not included in this proposal and are subject to further planning and outreach by CSOs and the SFMTA.

# OTHER APPROVALS RECEIVED OR STILL REQUIRED

The proposed on-street car share parking modifications are subject to environmental review under the California Environmental Quality Act (CEQA). On May 31, 2013, the Planning Department determined that the proposed on-street car share pilot program was categorically

exempt from environmental review under Class 6 (information collection activities which do not result in a serious or major disturbance to an environmental resource).

The City Attorney's Office has reviewed this report.

WHEREAS, The two-year pilot program will include qualified car share organizations who will be permitted exclusive and conditional use of on-street parking spaces in exchange for providing various data to evaluate the feasibility and effectiveness of on-street car sharing spaces; and,

WHEREAS, Designated on-street car share parking spaces must be approved by the SFMTA Board of Directors as required by the Transportation Code; and,

WHEREAS, The public has been notified about the proposed modifications and has been given the opportunity to comment on those modifications through the public hearing process; now, therefore, be it,
