PROGRESSIVE DISCIPLINE FOR VIOLATION OF RULES AND REGULATIONS FOR ALL PERMIT HOLDERS

[New Section: 1125]

Every Permit Holder who does not comply fully with any provision of this Article shall be guilty of a violation and the SFMTA shall assess the penalty as shown in Article 300, Section 310 of the San Francisco Transportation Code. A violation occurrence shall be every day during any portion of which the violation is committed; and each day that such a violation continues shall be considered a new and separate occurrence of the violation.

The record of action of the SFMTA to suspend a permit is separate and apart from the requirement of the Permit Holder to serve the suspension. The action of the SFMTA to suspend shall be recorded in the Permit Holder's file and will be considered when applying for or renewing a permit. A Permit Holder must serve a suspension during a period of time in which the permit has been surrendered to the SFMTA.

All new A-Cards will be issued on a probationary basis for the first 12 months after issuance. The A-Card can be automatically revoked for the following:

- Driver has more than two substantiated violations of Schedule A or B
- Driver has one substantiated Schedule C violation

An applicant who seeks to apply or renew a permit, and who has a record on file with the SFMTA, shall be denied a permit if the applicant's file indicates any of the following:

- a. More than five (5) violations within the last twelve (12) months;
- b. More than ten (10) violations last three (3) years;
- c. Revocation of a permit by the SFMTA within the last three (3) years;
- d. Convictions, during the preceding three years, for commission of a crime while operating a taxicab or other vehicle for hire in the state of California, including but not limited to those specified under Section 1103(c)(2)(F).

PROGRESSIVE DISCIPLINE SCHEDULES

The intent of progressive discipline is to allow for a Permit Holder to correct behavior. The SFMTA will use progressive discipline in correcting the behavior of a Permit Holder. The severity of each case will direct the appropriate progressive disciplinary action. The SFMTA has the discretion to skip any level of progressive discipline in appropriate circumstances. For the first violation of any rule for the same Progressive Penalty Schedule, a formal verbal or written admonishment may be issued prior to the issuance of a monetary fine and suspension.

In addition, the SFMTA reserves the right to issue additional suspension days or revoke a permit.

The following progressive penalties shall be applied when a Permit Holder is guilty of the second or subsequent violation of the same rule or any combination of the rules listed for the same Progressive Discipline Schedule within any 24-month period. Staff discretion within the discipline options noted is based on case by case review. Staff must have a written justification on file for type of discipline selected.

The monetary fines for Permit Holder violations are specified under Section 310. In place of suspension of a permit, a Permit Holder may render a monetary penalty of \$100 per suspension day. No monetary penalty will be allowed for suspensions of 21 days or more. In addition to serving a suspension or paying a monetary penalty, a Permit Holder must also pay the monetary fine specified under Section 310.

SEC. 310. SCHEDULE OF FINES.

Violation of any of the following subsections of the San Francisco Transportation Code governing the operation of a motor vehicle for hire shall be punishable by the administrative fines set forth below.
