Written statement by Edward Mason for minutes of SFMTA's Policy and Governance Committee May 20, 2016: Agenda Item 4, Public Comment:

We Drive U 2019 operates on Clipper Street 3 ton restricted and residential streets Church and Cesar Chavez – displays pilot placard 0S-018. Loop 4001, 4006, lack placards. Loop 195 displays pilot placard 07-008. Corinthian 248 operates between Sanchez and Church on 26th Street a 3 ton restricted street. Lux 29-09-5007 staged at eastbound 24th and Church obstructing one Muni and three commuter buses. Blue placard display is not uniform on all four sides of the vehicles. Making identification very difficult.
