The information is not collected and integrated into something meaningful. The SFMTA is redoing it now.

WHEREAS, The Mayor's Executive Directive 16-03 on "Achieving Vision Zero," calls for an analysis of targeted improvements to improve safety for, among others, seniors and people with disabilities, therefore the SFMTA CAC recommends that expanded enforcement of sidewalk parking, including a requirement that Parking Control Officers cite all sidewalk parking on sight, with no exceptions, and not just in response to complaints, and that enforcement of sidewalk parking be made a central element of the Vision Zero Plan.
