1 Call to Order

Chairman Nolan called the meeting to order at 2:05 p.m.

3. Announcement of prohibition of sound producing devices during the meeting.

Chairman Nolan announced that the ringing of and use of cell phones, pagers and similar sound-producing electronic devices are prohibited at the meeting. He advised that any person responsible for the ringing or use of a cell phone, pager, or other similar sound-producing electronic devices might be removed from the meeting. He also advised that cell phones that are set on "vibrate" cause microphone interference and requested that they be placed in the "off" position.

Board Secretary Boomer stated that staff has removed Item 10.1D from the agenda and that they would like to modify Item 11 with regard to oversized vehicle regulations on Illinois St. She also stated that there would be no discussion of anticipated litigation in closed session.

Chairman Nolan called Item 13 to allow present members of the public to address the Board. Following public comment, the Board returned to Item 6.

Sonali Bose, Director, Finance and Information Technology recognized Alexiy Sukhenko, Principal Administrative Analyst.

Director Reiskin discussed a meeting with Parking Control Officers, the new Line Management Center, and the establishment of a Van Ness BRT Citizens Advisory Council.

PUBLIC COMMENT:

Madeline Savit discussed progress on Polk Street despite those who have continued to stymie the process. Vision Zero is wonderful thing. City leaders have a duty to care for all residents.

Herbert Weiner stated that critical mass and cyclists who run red lights are dangerous.

9. Public Comment

Charles Minster expressed appreciation to those who make Muni run. They deserve all they ask for in the upcoming contract negotiations. He discussed what happened to a disabled person because the person didn't pay his fare. He suggested putting traffic control officers at dangerous intersections to save lives. The SFMTA can afford to give free transit to seniors and people with disabilities. More buses should be on the streets.

Vera Haile discussed the Elder Americans Act. The hazards of old age can be visited on anyone regardless of age. There 40 meal sites in the city. These are major places for people to get nutritious meals and socialize. She stated that she would hate to see means testing for income. The SFMTA shouldn't further economic inequality.

George Beiler discussed providing free transit to seniors. They are trying to live on a fixed income, they have medical problems and they worry about money. It's only fair that Muni be free for seniors.

Howard Strassner discussed driverless cars as the answer to many problems. Having a driverless taxi would eliminate the need for parking. The City has to welcome driverless cars.

Herbert Weiner applauded Google for funding the student youth fare and wished they would fund the entire budget. Barbary Coast has a conflict of interest. He requested clarification regarding the delivery of the New Flier buses.

Peter Mendoza expressed support for providing free transit for youth, seniors and people with disabilities. Many live on low income and the cost of living is high. Many have to make hard choices and they have to choose whether to go without food. Access to transportation is important as it allows seniors to fully participate in the community. People with disabilities are the most transit independent.

Under CEQA, in a later court challenge, a litigant may be limited to raising only those issues previously raised at a hearing on the project or submitted in writing to the City prior to or at such hearing, or as part of the appeal hearing process on the CEQA decision.
