Teresita Boulevard, west side, from 9 feet to 31 feet north of Marietta Street (North) curb ramp

ESTABLISH – TOW AWAY NO STOPPING ANYTIME

22nd Street, south side, from 140 feet to 199 feet west of San Bruno Avenue (removes yellow zone)

ESTABLISH - STOP SIGNS

- A. Hubbell Street, eastbound, at 7th Street, stopping the stem of this "T" intersection
- B. Irwin Street, eastbound, at 7th Street, stopping the stem of this "T" intersection

- A. Vicente Street, eastbound and westbound, from Lower Great Highway to 24th Avenue (Class II Bikeway)

- C. Vicente Street, eastbound and westbound, from 22nd Avenue to 20th Avenue (Class II Bikeway)
- D. Vicente Street, eastbound, from 19th Avenue to 17th Avenue (Class II Bikeway)

RESCIND – 45 DEGREE FRONT-IN PARKING

ESTABLISH - 45 DEGREE BACK-IN PARKING

13th Street, eastbound, between Folsom Street and Bryant Street (Class IV Bikeway)

ESTABLISH – TOW-AWAY NO STOPPING ANYTIME

- A. 13th Street, south side, from Folsom Street to Trainor Street (Removes 7 parking spaces and 5 motorcycle parking spaces)
- B. 13th Street, south side, from Trainor Street to 46 feet westerly (Removes 1 motorcycle parking space and 1 vehicle parking space)
- C. 13th Street, south side, between Trainor Street and Harrison Street (Removes 8 parking spaces)
- D. 13th Street, south side, from Harrison Street to 36 feet easterly (Removes 1 parking space)
- E. 13th Street, south side, from 331 feet to 361 feet east of Harrison Street (Removes 1 parking space)
- F. 13th Street, south side, from Bryant Street to 304 feet westerly (Removes 17 parking spaces)

ESTABLISH – NO RIGHT TURN ON RED (EXCEPT BICYCLES)

Harrison Street, northbound, at 13th Street

ESTABLISH - STOP SIGNS

- A. Isis Street, southbound, at 13th Street, stopping the stem of this T-intersection
- B. Bernice Street, southbound, at 13th Street, stopping the stem of this T-intersection
- C. Trainor Street, northbound, at 13th Street, stopping the stem of this T-intersection

<u>ESTABLISH – 2 HOUR PARKING, 8 AM TO 6 PM, MONDAY THROUGH SATURDAY</u>

13th Street, south side, between Harrison Street and Bryant Street

ESTABLISH – LEFT LANE MUST TURN LEFT

13th Street, eastbound, at Bryant Street

Mission Street, at Shaw Alley
