

PUBLIC HEARING RESULTS



Pursuant to SFMTA Order No. 5720, the San Francisco Municipal Transportation Agency held a public hearing on Friday, February 24, 2017 to solicit public input on the following proposed changes.

ESTABLISH – METERED YELLOW ZONE, COMMERCIAL LOADING 7AM TO 6PM, MONDAY

THROUGH SATURDAY

"102" 10th Street, west side, from 2 feet to 22 feet south of Mission Street, at metered parking stall #102 (20-foot zone)

RESCIND YELLOW METERED LOADING ZONE, 7 AM TO 6 PM, MONDAY THROUGH FRIDAY

Spear Street, west side, from 130 feet to 172 feet south of Mission Street, (meter spaces #116, 118)

<u>ESTABLISH – DUAL USE ZONE: METERED YELLOW ZONE, COMMERCIAL LOADING, 7 AM</u> <u>TO 3 PM, MONDAY THROUGH FRIDAY AND PASSENGER LOADING ZONE, 3PM TO 7 PM,</u> <u>MONDAY THROUGH FRIDAY</u>

Spear Street, west side, from 5 feet to 91 feet south of Mission Street, (meter spaces #102, #104, #106, #108) Spear Street, west side, from 191 feet to 235 feet north of Howard Street, (meter spaces #134, #136) Spear Street, west side, from 56 feet to 102 feet north of Howard Street, (meter spaces #144, #146)

ESTABLISH – DUAL USE ZONE: METERED YELLOW ZONE, 6-WHEEL COMMERCIAL LOADING, 7 AM TO 3 PM, MONDAY THROUGH FRIDAY AND PASSENGER LOADING ZONE, 3PM TO 7 PM, MONDAY THROUGH FRIDAY

Spear Street, west side, from 130 feet to 172 feet south of Mission Street, (meter spaces #116, #118) Spear Street, west side, from 235 feet to 275 feet north of Howard Street, (meter spaces #130, #132) Spear Street, west side, from 102 feet to 146 feet north of Howard Street, (meter spaces #140, #142) Spear Street, west side, from 10 feet to 56 feet north of Howard Street, (meter spaces #148, #150)

ESTABLISH – BLUE ZONE, DISABLED PARKING ONLY, AT ALL TIMES

"399" 9th Street, east side, from Harrison Street to 20 feet northerly, replacing metered parking stall #361 (20-foot zone)

ESTABLISH – BLUE ZONE, DISABLED PARKING ONLY, AT ALL TIMES

"777" Font Boulevard, south side of 700 Block of Font Boulevard east of the traffic circle (20-foot zone) Exact dimensions subject to post-construction conditions

ESTABLISH – PASSENGER LOADING ZONE, 7AM TO 10PM, DAILY

923 Folsom Street, south side, from 104 feet to 154 feet, east of Falmouth Street (50-foot zone)

REVOKE – YELLOW METERED LOADING ZONE, 8AM TO 6PM, MONDAY THROUGH FRIDAY ESTABLISH – DUAL USE ZONE: METERED YELLOW ZONE, COMMERCIAL LOADING, 8 AM TO 2 PM, MONDAY THROUGH FRIDAY AND PASSENGER LOADING ZONE, 2PM TO 7 PM, DAILY

2441 Mission Street, east side, from 188 feet to 228 feet south of 20th Street, at metered parking stall #2419 and #2421 (40-foot zone)
