To approve various routine traffic and parking modifications.

GOAL

- D. ESTABLISH NO PARKING ANYTIME, SIDEWALK WIDENING Van Ness Avenue, east side, from Sutter Street to 18 feet southerly. **PH 3/30/12 Requested by DPW.**

WHEREAS, The San Francisco Municipal Transportation Agency has received a request, or identified a need for traffic modifications as follows:

- A. ESTABLISH STOP SIGN Stopping westbound and eastbound San Juan Avenue at Otsego Avenue making this intersection an all-way stop.
- B. ESTABLISH RESIDENTIAL PERMIT PARKING AREA N, 2-HOUR PARKING, 9 AM TO 6 PM, MONDAY THROUGH FRIDAY 10th Avenue, 400-500-600 blocks, both sides, between Geary Blvd. and Cabrillo Street.
- C. ESTABLISH NO PARKING ANYTIME Coral Road, south side, between Carolina and Wisconsin Streets.
- D. ESTABLISH NO PARKING ANYTIME, SIDEWALK WIDENING Van Ness Avenue, east side, from Sutter Street to 18 feet southerly.

WHEREAS, The public has been notified about the proposed modifications and has been given the opportunity to comment on those modifications through the public hearing process; now, therefore, be it
