# PURPOSE

To approve various routine traffic and parking modifications.

## GOAL

- G. RESCIND NO PARKING, 9 AM TO 6 PM Holloway Avenue, north side, Ashton Avenue to Lunado Way.
- H. ESTABLISH TOW-AWAY NO PARKING ANYTIME Holloway Avenue, south side, from Junipero Serra Boulevard to Vernon Street; and Holloway Avenue, north side, from Ashton Way to Vernon Street.
