



Existing RPP Areas



- ❖ 29 permit areas
- 95,000 permits issued annually
- * 153,000 eligible households (44% of S.F. households)
- ❖ 78,000 permitted parking spaces (28% of on-street parking)
- Eligibility covers25% of City'sgeography

Typical RPP Regulations

- Monday through Friday (sometimes Saturday)
- 8 am to 6 pm
- 2-hour parking limit
 - Vehicles with RPP decal are exempt from limit
- No exemption from street cleaning, meters, red curb, etc.

Where is RPP Most Effective

- Residential neighborhoods that are low or medium density (such at North Bernal)
- Spillover parking from large traffic generator such as—
 - College
 - Transit station
 - Hospital
 - Sports / entertainment venue
 - Commercial corridor



RPP Increases Parking Availability

Area Q after new RPP signs were installed. This area had 90-99% occupancy on week days. At this point, not all residents had purchased their permits.

- Analysis of research findings and development of proposal: Fall 2016

North Bernal's Parking Concerns

- No existing regulations
- No street sweeping on some streets
- Cars not owned by local residents stored in Bernal
 - Resident of another block in Bernal?
 - Residents of the Mission?
 - Vacationers?
- BART and Muni commuters

Requirements

- 1. Neighborhood Support
 - Survey
 - Public hearings
 - Written comment

- 2. Parking Demand & Occupancy:
 - Threshold: > 80%
 - =Parked vehicles /legal on-street spaces

Requirements

3. Non-Resident Vehicles:

✓ How many?

4. Off-Street Parking Not Adequate:

- √ # Garages/driveways (MUST be used to park vehicles)
- ✓ Home built prior to automobile
- ✓ Sub-dividing homes w/out parking


Parking Occupancy Through the Day








North Bernal Route Z-2






Parking Occupancy Through the Day

North Bernal Route Z-2









Whose Cars are Parked in Bernal?

Half have no access to offstreet parking


Most have access to personal vehicle

- Saturday?
- 1-hour time limit?

RPP Reform Project

- 1. Improving efficiency and customer service using available technologies
- 2. Clarifying the process of establishing, extending, and modifying areas
- 3. Balancing parking demand and supply
- 4. Balancing neighborhood needs

Ideas Being Considered

- Neighborhood planning
- Modifying process of forming new area
 - North Bernal is first to use this process
- Establishing ultimate boundaries of RPP areas and dividing existing areas to correspond with natural neighborhoods
- Rationalizing hours of enforcement and parking time limits
- Improving process of purchasing permits

- 1. What if I do not own a car, but rent one for a few days or have visitors?
- 2. I own a business in the area. Can I get a permit?
- 3. I have care-takers come to my home every day. Can I get a permit for them?
