# 2. SFMTA Response to Memo presented by Robert Muehlbauer, CAC member, regarding CAC Management (25 minutes)

#### **CAC** comments

Aaron Goodman stated that he appreciates the support that the SFMTA provides to the CAC. More coordination is needed between the different transit agencies, and while there are transit agencies to focus on regional transit issues and the CAC is the local group to focus on how transit links can be improved and the SFMTA helps the CAC come up with solutions to these concerns.

Nell Selandar stated that she liked the "one-page" mini report that will be used by all project managers presenting before the CAC and suggested that a section be added requesting information about coordination with other agencies/departments.

Robert Muehlbauer stated the CAC has a broad scope of work and would like to see it be all it can be. He did not hear on how to reconcile the purpose of the CAC in regards to what the SFMTA can offer in terms of a staff report or staffing support. He questioned if the SFMTA required more funds or support from other transit agencies in order to provide staff reports. During the last year of his term on the CAC he will continue to advocate for staff reports.

3. Presentation regarding SFMTA/Muni's Service Equity Strategy. Informational Item Only. (Adrienne Heim, SFMTA Public Information Officer) 20 minutes

#### CAC comments:

Tiffany Ng stated that the organization she works for has provided comments to the SFMTA on the Plan.

Aaron Goodman stated that he was glad to see the posters on the street He mentioned routes that go through the area such as the #49, the J Church Metro line and the future Geneva-Harney BRT line. Connections between the various lines/services are key and need to be met. Texting is one way to reach people and that having people at boarding areas, schools, and tables at functions was also important. He asked that additional information should be shown on some of the slide. He wants to see a 10 year vision and big picture look of how to link and connect to service areas currently not being serviced.

Nell Selander remarked that the #8 and #8x and #23 should be included in the list of area bus routes. She stated that she doesn't take two buses since they don't connect and missing a connection is not great. The issue of not allowing bikes on light rail is not good for someone who could use their bake at the beginning or end of a trip but can't. She stated that Lyft and Uber are "cannibalizing" public transit and while those who identify as "transit dependent" aren't taking them. Public transit is losing riders to Lyft and Uber and the Board of Supervisors should be restrict the numbers allowed to operate.

Jessie Fernandez commented on wanting to advocate for the extension of the policy and wanted to hear about the work leading up to extending the policy might look like. With the Identification of key needs and there are more needs, community engagement is will only get better. Free Muni was an example of a community led effort to advocate for the passes and an example a level of engagement that is key to understanding what the barriers are to making the transit system something that is going to serve people's needs especially the seven (7) equity neighborhoods.

Robert Muehlbauer commended the outreach effort to talk to people face to face including talking to Muni operators and youth riders. On bus is excellent way to find out what people are thinking.

Tiffany Ng requested information on outreach goals.

#### **Public Comment**

Theodore, Excelsior resident –commented on the lack of the #14 and #49. Routes might be different on various days of the week. Consider the different uses according to days of the week and the different activities people do.

4. Presentation regarding Upper Yard Development. Informational Item Only (Sam Moss and Scott Falcon, Mission Housing Development Corporation) (20 minutes)

#### **CAC Comments**

Jessie Fernandez stated that he is excited about the building design and commended the team on working well with community based groups.

Nell Selandar wanted to know about the phasing schedule and how it would impact the Kiss and Ride area. She also asked about how the project would be financed.

Robert Muehlbauer commented that without a back, the building's design needs to be exciting on three sides and that there is the opportunity to create a great building and site. He stated that it is important that the developer works with BART to make the development a special place.

Aaron Goodman stated that it is important that the building have a ground floor space for building residents and the community. San Jose Avenue shouldn't become one large bus parking lot and that the developer should work with the SFMTA to ensue this. In addition, the design of the building should be one that enlivens the site and could also offer vibrant plazas for all to use.

#### **Public Comments**

Bonnie Ora Scherk stated that the site of the proposed building is part of the Islais watershed and wanted to know what thoughts the developers might have regarding water usage on the site.

Theodore, Excelsior Resident sated that water reclamation is required in California.

5. Presentation regarding Balboa Park Reservoir. Informational Item Only (Robert Muehlbauer, Liaison to Reservoir CAC) 20 minutes

Tiffany Ng stated that it was good to have an update on the project.

Nell Selander stated that she had the opportunity to attend a community meeting where they walked around the site.

Aaron Goodman commented on how the site can bring affordability to the neighborhood and be designed to connect without surrounding area.

#### **Public Comments**

Theodore, Excelsior resident stated that parking is a very contentious subject in the area and is a challenge for the SFMTA to balance the needs of students regarding a reduction in the number of parking spaces.

Ray Kutz, Sunnyside resident commented that the proposed TDM plan is a point of contention for many and implementation a concern since it the Plan is just a framework. Solutions proposed are not taking

into account the community. The parking problems will get worst with a decline in parking spaces for student use.
