Girard Street, east side, between Fratessa Court and Wilde Avenue

#### 3. <u>ESTABLISH – METERED MOTORCYCLE PARKING</u>

Howard Street, north side, from 29.5 feet to 40.5 feet west of Beale (converting remainder of former yellow meter #304 into three motorcycle spaces at 3.5 feet each, with a 2-foot buffer next to the adjacent blue zone) \*

- D. Lundy's Lane, both sides, between Coso Avenue and Fair Avenue
- E. Mirabel Avenue, both sides, between Coso Avenue and Shotwell Street
- F. Montezuma Street, both sides, between Coso Avenue and Shotwell Street
- G. Powers Street, both sides, between Mission Street and Coleridge Street
- H. Precita Avenue, both sides, between Mission Street and Folsom Street

18<sup>th</sup> Street, south side, from Texas Street to 75 feet easterly (restores 4 RPP parking spaces) 18<sup>th</sup> Street, south side, from Pennsylvania Avenue to 75 feet easterly

#### 7(c). ESTABLISH - TOW-AWAY, NO PARKING ANYTIME

18th Street, south side, from Pennsylvania Avenue to 75 feet easterly

#### 11(b). ESTABLISH - PARALLEL PARKING

Townsend Street, south side, from 43 feet west of west side of east crosswalk at 6<sup>th</sup> Street to 412 feet westerly (replaces existing 45 degree back in angled parking, results in a net decrease of 13 parking spaces)

#### 11(c). ESTABLISH - RED ZONE

- A. Townsend Street, south side, from 6<sup>th</sup> Street to 12 feet easterly (removes one metered parking space at meter #684-04890 space #4) \*

- C. 6<sup>th</sup> Street, east side, from 3.5 feet to 10.5 feet northerly (removes three motorcycle metered stalls, #206-06625, #206-06627, and #206-06629) \*

#### 11(d). ESTABLISH - TOW AWAY NO STOPPING ANYTIME

Townsend Street, north side, from 6<sup>th</sup> Street to 83 feet westerly (removes one non-compliant blue zone and one Area Y RPP parking space)
