## Payment Plan

- One Payment Plan per license plate. Enrolling \*
  multiple license plates will result in multiple payments
  plans with a minimum monthly amount due for each \*
  plan.
- Participant must present a valid government issued I.D. at the time of enrollment.
- Customers must make minimum monthly payments based on total amount enrolled in the plan. Failure to do so will result in plan cancellation.
- Citations are not eligible for enrollment if the cited vehicle is currently booted, towed, or previously paid with a disputed credit card charge.
- Citations enrolled in this program are not eligible for an Administrative Review or Hearing.
- DMV registration hold will not be removed until the Payment Plan has been completed.
- Only the Registered Owner may enroll in the Payment Plan. No rental cars.
- The monthly minimum is a suggested payment amount. The total amount due must be paid BY the DUE DATE.
- Citations cannot be added to existing plans. A new plan will be created with a new monthly minimum due.
- DMV Registration Hold will be lifted within 5 business days of completing your Standard Payment Plan.

- No re-registrations of citations, contract extensions or revisions will be granted.
- Non-refundable administrative fee due to SFMTA at time of enrollment.
- The payment plan is an attempt to collect the debt. Any information obtained can be used for this purpose.
