PUBLIC COMMENT:

David Pilpel read Charter Section 8A.104(r) and expressed concern that the agreements were not properly noticed in accordance with the Charter. He stated that the Board could not approve those four items until after 15 days. He urged the Board to hold a special



meeting on June 28 to consider the four agreements disclosed. He asked that staff provide the paragraph numbers that are affected, and he inquired if the analysis had changed. He also asked if he would receive a response to his recent letter to the Board.

Deputy City Attorney Susan Cleveland-Knowles stated that she will work with the Board Secretary and Chair to determine if the changes did change the analysis of the agreements and how best to move forward. She did not believe that the financial analysis changed.

California Environmental Quality Act (CEQA) Appeal Rights under S.F. Admin. Code Chapter 31: For identified Approval Actions, the Planning Department or the SFMTA has issued a CEQA exemption determination or negative declaration, which may be viewed online at the Planning Department's website. Following approval of the item by the SFMTA Board, the CEQA determination is subject to appeal within the time frame specified in S.F. Administrative Code Section 31.16 which is typically within 30 calendar days. For information on filing a CEQA appeal, contact the Clerk of the Board of Supervisors at City Hall, 1 Dr. Carlton B. Goodlett Place, Room 244, San Francisco, CA 94102, or call 415.554.5184. Under CEQA, in a later court challenge, a litigant may be limited to raising only those issues previously raised at a hearing on the project or submitted in writing to the City prior to or at such hearing, or as part of the appeal hearing process on the CEQA decision.

<u>Board of Supervisors review of certain SFMTA Decisions:</u> Certain parking and traffic modifications as well as Private Transportation Programs that involve certain parking modifications can be reviewed by the Board of Supervisors. These decisions are subject to review within 30 calendar days after they are made by the SFMTA Board of Directors.
