10 years ago

- Original effort did not produce plan
- 3 years ago
- Reinitiated the effort
 - Data collection confirmed curb congestion—lots of demand for finite supply as was determined in previous effort

Curb parking toolbox

Regulation	Description	Limits and Schedule
Time Limits	All vehicles must move before time limit	2 or 4 hours, depending on block Monday-Friday (9am-6pm)
Residential Permit Parking (RPP)	Vehicles without valid permit must move before time limit.	2 hours* Monday-Friday (9am-6pm) Permit holders exempt from time limit

Operations

- No time limit unless specified
- Monday-Saturday
- 9am-6pm

Payment options

- Parking card
- Coin
- Credit card
- By phone call
- By phone app
- By phone or web browser

Rates

- Start at base rate of \$0.50/hour for each timeband (morning, midday, evening for both weekdays and Saturday)
- Rates adjusted based on demand every quarter







Residential Permit Parking (RPP)

- New Area GG created
- Some blocks of Areas I and W will move to GG
- Within this area, as proposed, there are blocks with standard meters and time limits which apply to everyone. Blocks within this area signed GG exempt permit holders from the time limit or meter payment
- Residents, businesses, caregivers, teachers, active military, full-time students at higher education institution may receive permits
