Viktoriya Wise, Chief of Staff, shared about plans regarding Arguello Boulevard, the installation of the 300<sup>th</sup> bikeshare station in the Outer Sunset, extended parking meter hours, autonomous vehicles, Asian American & Pacific Islander Heritage Month, the Warriors recognizing Operator Angel Carvajal, and the recent passing of SFMTA staff, Margot Reed.

#### PUBLIC COMMENT:

Nick Levi expressed support for extending parking meter hours.

Speaker urged the SFMTA to stop wasting money.

Barry Taranto expressed confusion about parking meter difficulty with payments and parking meter officer enforcement at night.

Speaker recommended that the agency take money from elsewhere to help with transportation.

Speaker shared that the problem is with Muni management and suggested that it was time for pay cuts.



Speaker requested an agency audit be done to see where the money was going.

Michael Chen, Chair, Citizen's Advisory Council, presented the report.

#### PUBLIC COMMENT:

Barry Taranto appreciated the report and asked that larger venues facilitate use of taxi cabs and help with signage.

#### 9. Public Comment

Members of the public may address the SFMTA Board of Directors on matters that are within the Board's jurisdiction and are not on today's calendar.

Speaker expressed support for Slow Streets and shared that transit should be a backbone to the Slow Streets Network.

Josh Kelly shared that neighborways in the Sunset are lacking and encouraged the SFMTA to implement neighborways as son as possible.

James Wang expressed concern about speeding cars on Santiago Street.

Lucas Lux urged the Board to implement and apply Slow Streets metrics to the neighborways in the Sunset.

Speaker shared that he was tired of hearing from bike advocates about safety when San Francisco is the 2<sup>nd</sup> safest city in the nation.

Luke Bornheimer expressed support for all Slow Streets including those in the Sunset and urged the SFMTA to make streets safer.

Barry Taranto asked the SFMTA to require that taxi appeal hearings be listed on the website and available for the public to participate.

Matter involving unlitigated construction contract claims under Municipal Transportation Agency Contract 1289, related to the Van Ness Corridor Transit Improvement Project with SFMTA to pay \$17,535,525.68 (with expected contribution from SFPUC) and SFMTA to release \$6,464,474.32 of retention to contractor.

Code Chapter 31: For identified Approval Actions, the Planning Department or the SFMTA has issued a CEQA exemption determination or negative declaration, which may be viewed online at the Planning Department's website. Following approval of the item by the SFMTA Board, the CEQA determination is subject to appeal within the time frame specified in S.F. Administrative Code Section 31.16 which is typically within 30 calendar days. For information on filing a CEQA appeal, contact the Clerk of the Board of Supervisors at City Hall, 1 Dr. Carlton B. Goodlett Place, Room 244, San Francisco, CA 94102, or call 415.554.5184. Under CEQA, in a later court challenge, a litigant may be limited to raising only those issues previously raised at a hearing on the project or submitted in writing to the City prior to or at such hearing, or as part of the appeal hearing process on the CEQA decision.
