

Geary Improvements: Design/delivery in two phases

- Geary Rapid Project: Substantially complete; on-time, on-budget delivery
- Geary Boulevard Improvement Project: Finalizing design and legislation phase





Replacement parking update

SFMTA identified 17 additional replacement parking spaces for a total of 39 new parking spots. The new spaces are primarily possible by relocating the 14th/Geary, 21st/Geary, and 28th/Geary bike share stations as well as some additional cross street locations where angled parking can replace parallel parking on one side of the street.



+22 Originally planned replacement parking+17 Additional replacement parking spaces

*14th and Funston avenue locations are proposed for angled parking but would not create a net addition in parking.

Key merchant concerns and responses

Merchant concern	Project response
Minimize construction impacts	Design modified from center- to side-running, dramatically decreases construction impacts
Minimize parking loss due to transit lane	Identified an additional 17 parking spaces to almost entirely mitigate the 18 attributable to transit lane
Minimize parking loss	Significantly decreased parking loss to an average net loss of <1 spaces per block, saving almost twice as much parking as original center-running design (-31 spaces vs60 spaces)
Help Geary merchants' economic recovery	Project has committed to project-funded business support during both Quick-Build and full project construction
Location-specific feedback	Revised several project proposals in response to merchant feedback including dropping proposals to re-locate 17 th and 25 th Ave outbound stops, and changes to color curb plan
Do no harm to Geary parklets	Committed to cover costs to re-build directly impacted parklets
Delay implementation of Quick-Build project	Provided more information on Quick Build timing needs and benefits, included a "Delayed Transit Lane Option" alternative for consideration by the SFMTA Board of Directors



Key merchant concerns

Quick-Build phase impacts and mitigation

- No excavation. Striping and signage changes will take 1-2 days per block over about 3 months total
- Install new angled parking on cross streets *prior* to conversion of angled parking to parallel parking
- Changes to curb color for new/relocated loading zones (commercial, passenger, general)
- Safety improvements: red curb, left-turn restrictions, and retiming signals for slower walk speeds

Marketing support

SFMTA will convene a Merchant Working Group to cocreate a customized marketing campaign to support the Geary commercial district. Project has budget to facilitate meetings, prepare artwork/marketing materials and \$25,000 in direct costs to execute campaign. This is *in addition to* business support funds for the construction phase.


Key merchant concerns

Why implement Quick-Build before SFPUC construction?


- Act with urgency to decrease traffic injuries and deaths in the project area.
- Support the city's economic recovery by improving transit travel time and reliability for the 36,000 daily transit riders.
- Move forward with State grant-funded signal re-timing that must be spent by end of 2023. This signal retiming would also help keep buses and cars moving with improved signal progression.
- Traffic will flow smoother and more predictably by getting the bus out of the traffic lane and giving general traffic their own two lanes .
- Protect buses from delays and keep more on-street parking during SFPUC construction.



Example street configuration during construction with angled parking




Example street configuration during construction with parallel parking

Shared Spaces update

Shared Spaces In Angled Parking

- Joe's Ice Cream (northside, between 18th and 19th)
- **Trad'r Sam** (northside, between 25th & 26th)
- Eligible for reimbursement of costs to rebuild parklet into parallel configuration
- Tommy's, Blarney Stone, Nag's Head, Na Ya, Chomp n' Swig, Jin Pot have removed structures

Conflict with Far-Side Bus Stop Relocation

- Ireland's 32 (northside between 3rd and 4th Ave)
- Eligible for reimbursement of costs to remove parklet at time of Quick-Build implementation

Changes in Geary parking supply due to Shared Spaces program


- 39 parking spaces have been restored as of May 2023 within the project limits since peak Shared Spaces in operation in 2021
- An additional two spaces will be restored by fall 2023 (although businesses may choose to apply for a new Shared Space at any time)

Upcoming approval process

SFMTA Board will consider two options in August (tentative):

- 1. Approve and implement project as recommended by staff
- Delay implementation of some transit lanes along ten block faces until early 2025, delaying loss of 18 parking spaces. Would result in additional 600 hours of staff work, additional \$200,000 in costs, potential need for affected Shared Spaces to rebuild twice, and net loss of transit benefits (up to 10.5 hours for a daily 38 rider over ~18 month delay)



"Geary East" contract: Van Ness to Market Street

- Coordinated roadway repaying and contract punch-list are complete.
- Paint Shop has completed ~80% of the installation of red thermoplastic transit lane colorization. Awaiting overtime crew availability for completion of the red near bus stops, to minimize transit impacts
