10.2. Authorizing the Director to execute Master Agreements with Star Elevator Inc., Kone Inc., Schindler Elevator Corporation and TK Elevator Corporation for the maintenance of elevators and escalators in the Muni Metro System and at various SFMTA facilities for a period not to exceed five years from August 15, 2023 through August 14, 2028, in an amount not to exceed \$5,000,000 for each agreement. 10.3. Authorizing the Director to execute Contract Modification No. 1 to Contract No. 1316, Woods Facility Rehabilitation – Electric Bus Charging Station Pilot Program, with Liffey Electric, Inc., to close out the contract by extending the contract term and adjusting the quantity in the Schedule of Bid Prices to reflect the actual quantity of work performed. This Modification decreases the Contract amount by \$63.71, for a total Contract amount of \$2,693,936.29 and increases the overall Contract Time to substantial completion by 219 days for a total Contract Time of 489 days to Substantial Completion. Director Yekutiel requested the demographic breakdown of those conducting outreach as compared to the demographic breakdown of decision makers.

Director So requested additional data about outreach. Director Tumlin offered a briefing on ConnectSF.

Vice Chair Cajina requested disaggregated data by race and language demographics as well as more information around work happening with the agency and other partners in its next update.

Director Cajina recessed the meeting at 3:18pm and reconvened the meeting at 3:30pm.

Trish Gump expressed support for a bold plan that would allow any child or person of any ability to be able to choose whatever mode of transit to get around.

Zach Lipton urged the Board to push for a bold plan and shared that they also need resources in place to implement quickly.

Luke Bornheimer shared that the plan has the potential to be transformative and asked for a network map, policies that mandate the map, and a definition about what is enough outreach.

Eric Rozel requested that staff bring about the most urgent safety changes needed, sharing that it is imperative to see that planning efforts are implemented.

Stacey Randecker urged the SFMTA to act and help now, that they cannot wait for a plan to be completed.

Herbert Weiner expressed concern about outreach and whether it applies to seniors and the disabled.

Barry Taranto expressed concern about community outreach and a need to do more outreach.

California Environmental Quality Act (CEQA) Appeal Rights under S.F. Admin. Code Chapter 31: For identified Approval Actions, the Planning Department or the SFMTA has issued a CEQA exemption determination or negative declaration, which may be viewed online at the Planning Department's website. Following approval of the item by the SFMTA Board, the CEQA determination is subject to appeal within the time frame specified in S.F. Administrative Code Section 31.16 which is typically within 30 calendar days. For information on filing a CEQA appeal, contact the Clerk of the Board of Supervisors at City Hall, 1 Dr. Carlton B. Goodlett Place, Room 244, San Francisco, CA 94102, or call 415.554.5184. Under CEQA, in a later court challenge, a litigant may be limited to raising only those issues previously raised at a hearing on the project or submitted in writing to the City prior to or at such hearing, or as part of the appeal hearing process on the CEQA decision.

<u>Board of Supervisors review of certain SFMTA Decisions:</u> Certain parking and traffic modifications as well as Private Transportation Programs that involve certain parking modifications can be reviewed by the Board of Supervisors. These decisions are subject to review within 30 calendar days after they are made by the SFMTA Board of Directors.
