5. Report of the Chair (For discussion only)

Chair Leifer introduced Jeff Tumlin, Director of Transportation. Director Tumlin gave an update on the state of the SFMTA including the fiscal cliff, ridership, maintenance, autonomous vehicles, and Vision Zero.

Director Tumlin also introduced Director Lydia So, the newly appointed SFMTA Board member. Director So introduced herself to the CAC and stated that she is jazzed up to be a part of the SFMTA Board of Directors.

PUBLIC COMMENT:

Edward Mason stated that there should be a culture of safety developed. The SFMTA is trying to engineer its way out of the problems, but the root cause is a lack of safety and culture.



6. Public Comment

Edward Mason stated that the SFMTA needs to devote more attention to micro-mobility. There has been an increase in micro-mobility violations. Scooters, skateboards, and hoverboards are a growing safety hazard. There should be a regional campaign to invoke an awareness of safety.

Amelia Lindy stated that the SFMTA should re-evaluate the red curb program.

William Miles II, Manager, Talent Acquisition presented the item.

PUBLIC COMMENT:

Edward Mason asked how many applications were submitted versus the number of applicants hired. He also asked how many people have successfully completed the City Drive program. The birth rate has been declining in the United States and there are only 22.5 million people between the ages of 30 and 34. United States decarbonization goals require at least a million people working in the field to meet their goals for solar. The workforce age distribution, the residency of the employees, and anticipated retirement should all be forecasted. There should be "we're hiring" on the head signs of all buses, not just training buses.

The SFMTA CAC recommends that the agency's active communities plan establish a best practice of placing bicycle lanes curbside and protecting them, when concrete curbs are not available, with soft-hit posts spaced closely enough together that motor vehicles cannot drive between them. Additionally, the bicycle lane should be wide enough to accommodate a passing lane.
