Julie Kirschbaum, Director of Transit, Bree Mawhorter, Chief Financial Officer, and Kate Toran, Director of Taxis, Access, and Mobility Services, recognized staff.

Director Kirschbaum shared about the upcoming Asia-Pacific Economic Cooperation Leaders Meeting (APEC), end of session state legislation, Muni Heritage Weekend on September 23-24, new Customer Information System (CIS) signs, and the Central Subway Project winning the Engineering News-Record California's Regional Best Project award in the Best Airport/Transit category for Northen California.

#### PUBLIC COMMENT:

Barry Taranto thanked Annette Williams for her work with the agency and asked to be included in APEC planning.

Chair Eaken acknowledged Supervisor Myrna Melgar and welcomed her comment on Item 10.1A.

The Board heard Item 10.1A out of order.

# 8. Citizens' Advisory Council Report

Aaron Leifer, Chair of the Citizens' Advisory Council, presented the report.

#### PUBLIC COMMENT:

Speaker expressed support for extending meter hours and shared that it would result in more parking availability.

Stacey Randecker expressed support for extended parking meter hours.

Herbert Weiner expressed opposition to extended parking meter hours and suggested charging bicyclists for licenses and parking to generate revenue.

## 9. Public Comment



Members of the public may address the SFMTA Board of Directors on matters that are within the Board's jurisdiction and are not on today's calendar.

Tom Radulovich commented on the San Francisco General Plan.

Evan Oravec expressed concern about pedestrian safety, Vision Zero, and the intersection at 4<sup>th</sup> and King streets.

Luke Bornheimer urged the SFMTA to implement no turn on red lights citywide, sharing that it would make SF safer.

Jordan Smith shared about receiving several parking citations and filing public records requests for records.

Evelyn Engel expressed concern about taxi renewals beginning again and about taxi medallion enforcement.

Barry Taranto invited Directors Henderson and So to a future Taxi Alliance meeting and urged the SFMTA to prioritize enforcement against soliciting vehicles.

Speaker asked about upon requests stops and whether transit operators were still honoring those for seniors with disabilities.

Allie expressed concern about pedestrian safety and urged the SFMTA for a greater safety response.

Liz Bernsen expressed concern about pedestrian safety and urged the SFMTA to make structural improvements at dangerous intersections.

Stacey Randecker expressed concern for Vision Zero staffing and data collection, questioning why so little progress has been made.

Michael Beck expressed concern for the pedestrian fatality on  $4^{th}$  and King streets and realized it was the fault of those that design the roads.

Herbert Weiner expressed concern for pedestrians on the sidewalk and provided comment regarding taxi medallions.

Aaliyah expressed concern about pedestrian safety, sharing that the agency needs to take a more proactive approach at intersections.



Marcel Conseco expressed concern for medallion holders.

  - 10.1. Approving various routine parking and traffic modifications. (The Planning Department has found that items A-O are exempt from the California Environmental Quality Act [CEQA]. For these parking and traffic modifications that received a categorical exemption, the proposed action is the Approval Action as defined by Chapter 31 of the San Francisco Administrative Code. Explanatory documents include a staff report and resolution.):

    - C. ESTABLISH BUS ZONE Donahue Street, north side, from 100 feet to 165 feet east of Innes Avenue.
    - D. RESCIND WHITE ZONE, ACCESSIBLE PASSENGER LOADING 24th Street, south side, from 12 feet to 60 feet east of Mission Street.
    - E. RESCIND GENERAL METERED PARKING 24th Street, south side, from 60 feet to 108 feet east of Mission Street.
    - F. ESTABLISH TOW-AWAY, NO STOPPING ANY TIME 24th Street, south side, between Mission Street and Lilac Street.
    - G. ESTABLISH BUS ZONE Chumasero Drive, west side, from Font Boulevard to 136 feet southerly.
    - H. ESTABLISH TOW-AWAY, NO STOPPING ANY TIME Chumasero Drive, east side, from Font Boulevard to 150 feet southerly.
    - I. RESCIND BLUE ZONE Buena Vista Avenue West, east side, from 3 to 13 feet north of Waller Street park entrance.



- J. RESCIND TOW-AWAY NO PARKING ANY TIME, EXCEPT CAR SHARE Buena Vista Avenue West, east side, from 13 to 33 feet north of Waller Street park entrance.
- K. ESTABLISH BLUE ZONE Buena Vista Avenue West, east side, from 3 to 21 feet north of Waller Street park entrance.
- L. ESTABLISH TOW-AWAY NO PARKING ANY TIME, EXCEPT CAR SHARE Buena Vista Avenue West, east side, from 21 to 41 feet north of Waller Street park entrance.
- M. ESTABLISH PERPENDICULAR PARKING Buena Vista Avenue West, east side, from 30 to 48 feet south of Waller Street park entrance.
- N. ESTABLISH PARALLEL PARKING Buena Vista Avenue West, east side, from 48 to 100 feet south of Waller Street park entrance, Buena Vista Avenue East, east side, from 475 to 525 feet north of Upper Terrace.
- O. ESTABLISH RED ZONE Buena Vista Avenue East, east side, from 525 to 535 feet north of Upper Terrace.

Zach Lipton shared about safety and project delivery, urging the SFMTA to make a bold commitment and be transformational.

Stacey Randecker expressed concern over vehicles and motorists being prioritized, sharing that staff should be out building to reach vision zero.

Trish commented on climate change and shared that the agency must take positive steps to reducing green house gas emissions by shifting from car dependent lives.

Robin Pham urged the SFMTA work now that that the agency has the staff to execute the plan without gaps and in a timely manner.

Eric Rozel urged the SFMTA to secure funding sources and work with Fire and Public Works, and encouraging the city to prioritize the safety needs of Tenderloin community.

Cyrus Hall commented on resource constraints and asked the Board to consider voicing frustration over the lack of engagement with the mayor.

Code Chapter 31: For identified Approval Actions, the Planning Department or the SFMTA has issued a CEQA exemption determination or negative declaration, which may be viewed online at the Planning Department's website. Following approval of the item by the SFMTA Board, the CEQA determination is subject to appeal within the time frame specified in S.F. Administrative Code



Section 31.16 which is typically within 30 calendar days. For information on filing a CEQA appeal, contact the Clerk of the Board of Supervisors at City Hall, 1 Dr. Carlton B. Goodlett Place, Room 244, San Francisco, CA 94102, or call 415.554.5184. Under CEQA, in a later court challenge, a litigant may be limited to raising only those issues previously raised at a hearing on the project or submitted in writing to the City prior to or at such hearing, or as part of the appeal hearing process on the CEQA decision.

Board of Supervisors review of certain SFMTA Decisions: Certain parking and traffic modifications as well as Private Transportation Programs that involve certain parking modifications can be reviewed by the Board of Supervisors. These decisions are subject to review within 30 calendar days after they are made by the SFMTA Board of Directors.
