1. ELIGIBILITY CHECKLIST

You are eligible to receive this rebate if **ALL** the following apply to you:

- You are a current active medallion holder, color scheme, or taxi driver with a valid A-card in good standing.
- You have purchased or leased an EV (electric vehicle) as a replacement for your previous gas-powered or hybrid taxi vehicle.
- Your EV has been fully introduced into the taxi fleet and is actively providing trips.
- You agree to operate your EV as a taxi for a minimum of two (2) years.
- Your EV is properly transmitting trip data.
- You have placed a grant sticker on the EV signifying your participation in the Bay Area Air Quality Management District (BAAQMD) grant – contact SFTaxi@sfmta.com to receive the sticker.

2. REQUIRED DOCUMENTS

EV Taxi Vehicle Replacement Documentation (in addition to this Eligibility Checklist):

- Vehicle Registration**
- IRS Form W-9**

Proof of sale (ONE of the following):

- Copy of Sales Invoice** (if from a dealer or auction)
- Purchase Order** (if from a dealer or auction)
- Vehicle Lease Agreement** (if EV is leased – must be for a minimum of three years)

Payment (ONE of the following):

- Deposited Purchase Check** (if from a private party sale) **Bank Statements** (leased vehicles only)
- Cashier's Check*** (in APPLICANT'S name)

Photos

- EV **before and after** conversion to a taxi
- Grant sticker** placed on the EV

(For large cab company fleet purchases only) **Spreadsheet** listing each EV's

- Make**
- Model**
- Year**
- Fuel Type** (any vehicle eligible for the rebate should be "Electric")
- Vehicle Identification Number (VIN)**
- Date of First Service as a Taxicab**

***NOTE: We will NOT accept photos of cash or Vehicle Transfer Forms as valid proof of purchase. For cash payment, we will only accept cashier's checks IN APPLICANT'S NAME.**

3.2 ADDITIONAL DOCUMENTS FOR SCRAPPED VEHICLES

Previous Taxi Vehicle Documentation:

- Vehicle Registration** (must demonstrate vehicle’s use as a taxi for at least two years)
- IRS Form W-9**

Photos

- Vehicle operating as a taxi
- Receipt** from authorized vehicle dismantler showing **surrender of vehicle’s title**

4. REBATE AMOUNT FOR NON-SCRAPPED VEHICLES

If you choose NOT to scrap your previous taxi vehicle:

You may receive a rebate of **\$3,750**

** A taxi operator or company who **chooses not to scrap** their previous vehicle may receive \$3,750 **regardless of the model year and fuel type of their previous vehicle and does not need to provide any documentation for the previous taxi vehicle** (only EV taxi vehicle replacement documentation).*

4.1 REBATE DISTRIBUTION SCHEME

The rebate is **split into three amounts** that are **distributed across two years** in the following scheme:

REBATE SCHEME	AMOUNT (Percent of Total)	DISTRIBUTION TIMELINE
1 st Amount	50%	Upon approval
2 nd Amount	25%	After 1 st year of eligibility
3 rd Amount	25%	After 2 nd year of eligibility
