#### **PURPOSE**

The purpose of this calendar item is to establish the 2024 SFMTA Board of Directors and Parking Authority Commission meeting schedule.

## STRATEGIC PLAN GOALS AND TRANSIT FIRST POLICY PRINCIPLES

Adopting a proposed schedule for meetings does not directly forward any of the SFMTA's Strategic Plan Goals nor Transit First Policy Principles, but it supports all goals and principles.

## **DESCRIPTION**

Establishing the meeting schedule will allow staff to manage their workflow in a more time and cost-effective manner and will help to ensure the smooth approval and delivery of projects.

Once approved by the SFMTA Board of Directors, the meeting schedule will be posted on-line and notice for all meetings will be posted in accordance with public meeting laws.
