Directors Heminger, So, Henderson, and Hinze appreciated Director Yekutiel for his work.

Director Tumlin introduced Julie Kirschbaum, Director of Transit, and Bree Mawhorter, Chief Financial Officer, who recognized Leslie Bienenfeld, Manager of the Transit Special Operations, and Diana Hammons, Senior Manager of Revenue Collection & Sales, for their contributions to Outside Lands.

Director Tumlin shared about the upcoming Asia-Pacific Economic Cooperation Leaders Meeting (APEC), autonomous vehicles (AV), state funding distribution, the Metropolitan Transportation Commission's (MTC) bikeshare investment and expansion, a recent committee meeting for the International Association of Public Transit (UITP) and North America Workshop on Zero Emission Fleets, a recent racial equity event with the Office of Racial Equity and Belonging, and about the Bus Roadeo.

PUBLIC COMMENT:

Speaker reflected on the future and expressed concern about bikes.

Mark Leeson expressed concern about AVs and AV crashes, applauding City Attorney David Chiu's efforts to challenge the state decision and urging the SFMTA to join the effort.

Stacey Randecker shared that the AV issue is a people issue, urged the City to use APEC resources for San Franciscans, and was supportive of the bikeshare funding.

Pete Wilson expressed concern about APEC impacts and asked staff supervisors for patience towards transit operators.

Luke Bornheimer commented on AVs and asked AV companies to instead fund the SFMTA.

Herbert Weiner urged the SFMTA to add more trolleys to the fleet.



Barry Taranto commented on APEC, asked that taxi stop information be shared, and expressed concern for residents that live near Moscone Center.

8. Citizens' Advisory Council Report

No report.

9. Public Comment

Members of the public may address the SFMTA Board of Directors on matters that are within the Board's jurisdiction and are not on today's calendar.

Anthony Ballester expressed concern for senior transit operators and their inability to go on vacation.

Kate Blumberg commented on the 48 Quintara/24th Street bus line, expressed concern for students getting skipped at bus stops near schools, and shared that bus reliability is critical.

Stacey Randecker commented about decision making and taking into consideration the City's Transit First principles when making decisions.

Fred Muhlheim expressed support for transit and shared concern about the Frida Kahlo Quick-Build Project.

Speaker expressed concern about a lack of parking, impacts to small businesses, and asked the SFMTA to add more parking.

Wendy expressed concern about removing parking and the need for a car for basic needs such as grocery shopping.

Li Chun Li expressed concern about parking availability in Chinatown and hoped that a lot could be opened there.

Speaker expressed concern about parking availability and asked the SFMTA to create more parking so that the elderly and working people could travel more easily.

Speaker expressed concern about unreliable transit and asked the SFMTA to move bicycle parking to the sidewalk to open up more parking on the curb.

Rex Ridgeway urged the SFMTA to increase bus service due to pass ups at schools.



Julia Toscano shared her experience about parking citations received while living near and attending San Francisco State University.

Jenny expressed concern about parking and asked for more angled parking in the Sunset neighborhood.

Pete Wilson expressed concern about treatment of fare inspectors.

Josephine expressed concern for multi-generational families that live in Chinatown, sharing that cars are needed for basic needs.

Luke Bornheimer urged the Board to approve a no turn on red citywide policy and expressed concern about Valencia Street crash and injury data.

Herbert Weiner commented about remote public comment and urged the SFMTA to add more buses to the fleet.

Adam expressed concern about street safety in the SoMA neighborhood and about safety on Valencia Street.

Speaker urged the SFMTA to improve bus service for students, adding that poor service leads to truancy and attendance issues for the school district.

California Environmental Quality Act (CEQA) Appeal Rights under S.F. Admin. Code Chapter 31: For identified Approval Actions, the Planning Department or the SFMTA has issued a CEQA exemption determination or negative declaration, which may be viewed online at the Planning Department's website. Following approval of the item by the SFMTA Board, the CEQA determination is subject to appeal within the time frame specified in S.F. Administrative Code Section 31.16 which is typically within 30 calendar days. For information on filing a CEQA appeal, contact the Clerk of the Board of Supervisors at City Hall, 1 Dr. Carlton B. Goodlett Place, Room 244, San Francisco, CA 94102, or call 415.554.5184. Under CEQA, in a later court challenge, a litigant may be limited to raising only those issues previously raised at a hearing on the project or submitted in writing to the City prior to or at such hearing, or as part of the appeal hearing process on the CEQA decision.

<u>Board of Supervisors review of certain SFMTA Decisions:</u> Certain parking and traffic modifications as well as Private Transportation Programs that involve certain parking modifications can be reviewed by the Board of Supervisors. These decisions are subject to review within 30 calendar days after they are made by the SFMTA Board of Directors.
