The SFMTA has approved your permit application for participation in the Commuter Shuttle Program from July 1, 2023, through June 30, 2024. This letter constitutes the Commuter Shuttle Permit No.10, authorizing Storer Transportation (Permittee) to participate in SFMTA's Commuter Shuttle Program. Permittee shall abide by all requirements set forth in the Permit Terms and Conditions for Permit Year 2023-2024, available at <u>2023-2024 Commuter Shuttle Permit Terms and Conditions</u> and incorporated by reference.

Under the terms of this permit, Permittee is authorized to load and unload passengers at Designated Network zones in accordance with the Permit Terms and Conditions and using only those vehicles bearing the license plates on the list of Authorized Vehicles maintained on Permittee's Salesforce profile, which is incorporated by reference.

The Designated Network consists of zones legislated by the SFMTA for use by permitted commuter shuttle buses. The Designated Network zones are available at <u>www.sfmta.com/commutershuttles</u>.
