Chair Eaken shared about the recently released Mayor's Transportation Vision, attending a 10-year Vision Zero event, and the 3<sup>rd</sup> Street Quick-Build Ribbon Cutting.

Director Tumlin provided an update on Vision Zero, Fix-It Week update, a new paratransit rider guide, the 3<sup>rd</sup> Street Quick-Build Ribbon Cutting event, scooter permit application window opening, Bruce Springsteen signage, and recent cable car gripman acknowledgement.

#### PUBLIC COMMENT:

Richard Rothman expressed concern about Vision Zero and commented on safety at 37<sup>th</sup> Avenue and Fulton Street.

Tom Radulovich shared about the Mayor's press event and expressed concern about Public Works and the Public Utilities Commission needing to be partners in streets safety work.

Jodie Mederios commented about the Vision Zero event and encouraged the SFMTA to work together.

Michael Adams expressed concern about the Frida Kahlo Way Quick-Build Project.

Luke Bornheimer expressed concern about Vision Zero and a need for immediate action, commenting about mode shift and shifting away from cars.

Herbert Weiner expressed appreciation for transit service and concern about bikes and scooters on sidewalks, urging collaboration with the police department.

#### 9. Public Comment

Members of the public may address the SFMTA Board of Directors on matters that are within the Board's jurisdiction and are not on today's calendar.



Richard Rothman suggested that the SFMTA take over street repair projects from Public Works and shared that blue zones on McAllister and Franklin streets have not been installed.

Tom Radulovich commented on the SFMTA as an enterprise department, questioning its value.

Marcelo Fonseca expressed concern about appeals process for taxi drivers and enforcing on medallion holders who cannot drive.

Barnett Trzcinski suggested a policy for a minimum mode share requirement across corridors for quick build projects and improving community outreach processes to be representative and equitable.

Carl Macmurdo expressed concern for taxi drivers and urged the Board to return money to medallion holders.

Luke Bornheimer thanked staff for No Turn on Red at 200 intersections downtown and urged the Board to approve a citywide policy.

Speaker expressed frustration about a recent citation and not receiving mailed notice.

Herbert Weiner expressed concern about representation of motorists and cyclists and the need to grow the fleet to provide more service.

  - 10.1. Approving various routine parking and traffic modifications and making environmental review findings: (The Planning Department has found that Items A-F are exempt from the California Environmental Quality Act [CEQA]. For these parking and traffic modifications that received a categorical exemption, the proposed action



is the Approval Action as defined by Chapter 31 of the San Francisco Administrative Code. Explanatory documents include a staff report and resolution.)

- A. ESTABLISH RESIDENTIAL PERMIT PARKING AREA U (Eligibility only, no signs) 1375 Harrison Street.
- B. ESTABLISH RESIDENTIAL PERMIT PARKING AREA C (Eligibility only, no signs) 1000-1014 Larkin Street.
- C. ESTABLISH RED ZONE Oxford Street, west side, from 22 feet to 32 feet north of Wayland Street.
- D. ESTABLISH TOW-AWAY, NO STOPPING ANY TIME Wayland Street, south side, from Oxford Street east property line extension to 104 feet northwesterly.
- E. ESTABLISH TOW-AWAY, NO STOPPING ANY TIME ESTABLISH SIDEWALK WIDENING, Wayland Street, south side, from Yale Street to 23 feet easterly, Yale Street, east side, from Wayland Street to 22 feet southerly.
- F. ESTABLISH WHITE ZONE, PASSENGER LOADING ONLY, 5-MINUTE TIME LIMIT, AT ALL TIMES, EVERYDAY, ACCESSIBLE SYMBOL Wayland Street, south side, from 71 feet to 93 feet east of Yale Street Wayland Street, south side, from 2 feet to 24 feet east of Princeton Street.

On motion to amend the resolution, adding to the 13<sup>th</sup> Whereas clause: "WHEREAS, A significant portion of the streets along the City's waterfront are currently on the High Injury Network, the 12% of streets where 68% of fatalities and serious injuries occur, and San Francisco adopted a Vision Zero goal in 2014 to eliminate all serious injuries and fatalities by 2024...", to the first bullet of the 2<sup>nd</sup> Resolve clause: "including dedicated infrastructure for people of all ages and abilities to take transit, walk, bike and use mobility devices safely and comfortably, without fear of harm. The waterfront will include...", to the third bullet of the 2<sup>nd</sup> Resolve clause: "Latinx and Latino" and approve as amended:

11. Presentation and discussion on the Fiscal Year 2024-2025 and Fiscal Year 2025-2026 Operating and Capital Budget including the Muni 2024 Network Title VI Service Equity Analysis. (Explanatory documents include a slide presentation.)

Bree Mawhorter, Chief Financial Officer, presented the item.

#### PUBLIC COMMENT:

Marcelo Fonseca expressed concern about the taxi system and fees, sharing that this was not the time to restart fees on a struggling industry.

Carl Macmurdo commented about ability to do revenue bonds and thanked the SFMTA for waiving taxi fees.

Mark Gruberg urged the Board to waive taxi fees for all drivers, sharing that the taxi system is broken.

Speaker shared that agency should be equally increasing fees to cars, sharing that any increase to Clipper cost would reduce use.

Cyrus Hall commented on focusing on equity between drivers and riders and expressed support for budget option 6.

Dylan Fabris expressed concern about the budget, sharing that the SFMTA should pass a budget that reflects its values, and urged the Board to support budget option 6.

Jaime Viloria expressed concern about raising fares, shared statistics about the Tenderloin community and concern that car users are not taking more of the burden in the budget.

Tom Radulovich presented revenue options including implementing charging for meters on evenings and Sundays, matching the taxi proposals for options 6 and 7, lowering the parking fines as much as possible.

California Environmental Quality Act (CEQA) Appeal Rights under S.F. Admin. Code Chapter 31: For identified Approval Actions, the Planning Department or the SFMTA has issued a CEQA exemption determination or negative declaration, which may be viewed online at the Planning Department's website. Following approval of the item by the SFMTA Board, the CEQA determination is subject to appeal within the time frame specified in S.F. Administrative Code Section 31.16 which is typically within 30 calendar days. For information on filing a CEQA appeal, contact the Clerk of the Board of Supervisors at City Hall, 1 Dr. Carlton B. Goodlett Place, Room



244, San Francisco, CA 94102, or call 415.554.5184. Under CEQA, in a later court challenge, a litigant may be limited to raising only those issues previously raised at a hearing on the project or submitted in writing to the City prior to or at such hearing, or as part of the appeal hearing process on the CEQA decision.

Board of Supervisors review of certain SFMTA Decisions: Certain parking and traffic modifications as well as Private Transportation Programs that involve certain parking modifications can be reviewed by the Board of Supervisors. These decisions are subject to review within 30 calendar days after they are made by the SFMTA Board of Directors.
