- 1a)RESCIND METERED YELLOW ZONE, 6-WHEEL COMMERCIAL LOADING, 30-MINUTE LIMIT, 8AM TO 6PM, MONDAY THROUGH SATURDAY
- 1b)ESTABLISH METERED GREEN ZONE, SHORT TERM PARKING, 30-MINUTE LIMIT, 9AM TO 6PM, MONDAY THROUGH SATURDAY
 - 6126 Geary Boulevard, north side, from 114 feet to 134 feet east of 26th Avenue at meter stall number 6112 (20-foot zone)
- 1c)RESCIND METERED YELLOW ZONE, 6-WHEEL COMMERCIAL LOADING, 30-MINUTE LIMIT, 8AM TO 6PM, MONDAY THROUGH SATURDAY

This would relocate and shorten the yellow commercial loading zone to the end of the block to facilitate truck loading and add a green meter to improve customer access.

Public Comments: A member of the public had concerns that some of these design sizes will not fit all vehicles and that intersection visibility should be provided. **Decision:** Approved by the City Traffic Engineer for implementation.

2. <u>Geary Boulevard between 3rd Avenue and 4th Avenue – Establishing a General Loading Zone</u>

This would establish a new general loading zone to facilitate customer access.

Public Comments: A member of the public had concerns about the legal establishment of general loading zones.

Decision: Approved by the City Traffic Engineer for implementation.

Public Comments: A member of the public supported loading for a daycare but had concerns about the length of the zone.

Decision: Approved by the City Traffic Engineer for implementation.

Per request from Booker T Washington Community Center to provide additional passenger loading.

Public Comments: Several emails from nearby residents were received stating opposition to the extended zone as it would remove parking for residents. A letter of support was submitted by the SFMTA Transit Division as current double parking inhibits transit operations. The Director of the on-site pre-school stated their support as expanding the white zone will help facilitate school pick and drop offs as they have expanded their programs and would improve safety for children and seniors who need more loading in front. Another staff person support in support of the white loading zone as it will provide space for food truck loading, and they need better traffic mitigation. Staff from John Burton Housing spoke in support of passenger loading. Another staff person stated their support as their needs have expanded and grown and this white zone will help protect community by avoiding Muni line congestion. A member of the public stated concerns over the



placement of a bike rack and that the hours should be revised to make it simpler to understand.

Decision: Approved by the City Traffic Engineer for implementation.

5. <u>43rd Avenue between Irving Street and Judah Street – Establishing an Accessible</u> Passenger Loading Zone

Public Comments: The applicant spoke in support of the zone as it will provide loading space for residents. A member of the public supported the loading zone but had concerns about the length of the zone.

Decision: Language amended per the request of the applicant; hours for the zone were changed from 7AM to 10PM to 8AM to 8PM. Approved by the City Traffic Engineer for implementation.

Public Comments: Two members of the public expressed concerns about the removal of the zone and the potential double-parking impacts it would have on Muni operations. **Decision:** The sponsor has made payment on this zone. Item not approved by the City Traffic Engineer for implementation.

Decision: Approved by the City Traffic Engineer for implementation.

Public Comments: One of the small businesses on the ground floor of this building expressed support for the zone as it provides space for their customers and there is no other loading space because the other side of their building is red curb for the bike lane. The property manager stated that this zone is critical to help support the five retail tenants in the building. A member of the public stated general loading zones cannot be enforced. **Decision:** The title of this item was amended as it incorrectly stated "Establishing a Passenger Loading Zone" rather than a general loading zone, which is what the legislation states. Approved by the City Traffic Engineer for implementation.

A member of the public stated that these were unusual regulations and was being done to result in more citations. Another member of the public stated that there is no enforcement on Sundays.

Decision: Approved by the City Traffic Engineer for implementation



22. <u>Alemany Boulevard between Onondaga Avenue and Seneca Avenue - Establishing Accessible Passenger Loading</u>

ESTABLISH - WHITE ZONE, ACCESSIBLE PASSENGER LOADING, 5-MINUTE LIMIT, 7AM TO 10PM, DAILY

1975 Alemany Boulevard, east side, from 352 feet to 396 feet south of Onondaga Avenue (44-foot zone), Excelsior, Supervisor District 11, Mari Hunter, mari.hunter@sfmta.com

Per project review through SDAT this would provide accessible passenger loading zones for the BRIDGE Housing development.

Public Comments: The sponsor spoke in support of the proposal as it would provide loading space for residents. A member of the public stated that the zone was too short. **Decision:** Approved by the City Traffic Engineer for implementation

23. <u>Farallones Street between Plymouth Avenue and San Jose Avenue – Extending a</u> Passenger Loading Zone

23b)ESTABLISH – WHITE ZONE, PASSENGER LOADING, 8AM TO 9:30AM AND 3PM TO 5PM, MONDAY THROUGH THURSDAY, AND 8AM TO 9:30AM AND 1PM TO 3PM ON FRIDAY

55 Farallones Street, south side, from 39 feet to 127 feet (starting from west property line) east of Plymouth Avenue (88-foot zone), Ocean View, Supervisor District 11, Color Curb Program, ccp@sfmta.com

Per request from school to accommodate higher loading capacities.

Public Comments: The school spoke in support of the item as there is currently double parking on a narrow street which is creating safety concerns. A larger zone would help address this issue. A resident submitted an email and spoke in opposition of the item as it would remove residential parking. A member of the public spoke in support of the item stating three spaces is too small.

Decision: Item amended to reduce the proposed zone from 110 feet to 88 feet. Approved by the City Traffic Engineer for implementation.

General Public Comments

A member of the public stated they believe that the comments provided will not go to the City Traffic Engineer. They also stated they believe that it is illegal to have a one-minute time limit for public comment and this is being done to force people into not providing comments.



Whether or not the City Traffic Engineer's decision is considered a Final SFMTA Decision is determined by Division II, Section 203 of the Transportation Code. If the City Traffic Engineer approves a parking or traffic modification, it is considered a Final SFMTA Decision. If the City Traffic Engineer disapproves or declines a parking or traffic modification, a member of the public must request additional review by the SFMTA of that decision, which shall be conducted pursuant to Division II, Section 203 of the Transportation Code before the decision becomes a Final SFMTA Decision. Final SFMTA Decisions, whether made by the City Traffic Engineer or the SFMTA Board, can be reviewed by the Board of Supervisors pursuant to Ordinance 127-18. Decisions reviewable by the Board of Supervisors are denoted with a pound (#).
