2. Presentation on proposed #54 Felton Bus Route Changes. <u>Informational Item Only.</u> (SFMTA Public Relations Officer Bonnie Jean von Krog and SFMTA Transportation Planner Tracey Lin) 20 minutes

Public Comments:

Ren Volpe passed out a diagram showing the route. She stated that she was in favor of the shift and change due to the street width. She stated that there was not documentation of why the route was removed. She stated that many cars were hit by the bus due to the narrow width of the street. Larger buses have created problems with cars backing up and she is surprised that no one has been hurt.

3. Presentation Geneva Car Barn and Powerhouse Project. Informational Item only. SF Recreation and Parks Planner Reem Assaf), 20 minutes

4. Presentation on Geneva -San Jose Intersection Study. Informational Item Only. (SFMTA Engineer Tony Henderson) 25 minutes

Public Comment- John Winston stated that is can be difficult to navigate the intersection on a bike especially when the tracks are wet. He wondered if something could be done to install a channel, similar to what is at Dubose and Church, where there is an island separated by a bike lane.

- Aaron Goodman stated that San Francisco State University is seeking comments on the 2035
 Master Plan. Comments are due on December 5, 2018. due to increased enrollment and
 lacking transit changes in D7 with Parkmerced, SFSU-CSU and Stonestown growth,
 that Ocean Ave and the Balboa Park Station will be impacted with SFSU-CSU and CCSF
 growth, and that it is important that CAC members and members of the public
 comment on these EIR's in relation to public transportation impacts.
