## **54 Felton Project**



The 54 Felton Project is proposing to realign the 54 Felton inbound routing to match the current outbound routing.

Benefits of this project include:

- Improving safety by shifting the bus onto a wider street
- Offering a more direct ride, running both ways on Moscow Street
- Net gain of one parking space in the project area

In the Excelsior District, between Geneva Avenue and Avalon Avenue, the following parking and traffic changes are proposed:

- Moving the 54 Felton to run on Moscow Street in both directions
- Parking restrictions at Moscow Street at Russia Avenue and Moscow Street at Persia Avenue
- All-way stop at Moscow Street at Excelsior Avenue, stopping northbound and southbound Moscow Street
