ESTABLISH – WHITE ZONE, PASSENGER LOADING 8AM TO 9:30AM AND 3PM TO 6PM, MONDAY THROUGH FRIDAY

49 Page Street, south side, from 203 feet to 245 feet west of Franklin Street, at metered stalls no. 23-G and 21-G (42-foot zone)
