FOR PROPOSED PARKING & TRAFFIC CHANGES

Pursuant to SFMTA Order No. 5815 adopted August 18, 2017, the San Francisco Municipal Transportation Agency will hold a public hearing to solicit public input on the following proposed changes. The hearing will be held as follows:

Date/Time: Friday, September 1, at 10:00 am
Location: Room 416 (Hearing Room 4), City Hall, San Francisco
(located on Van Ness Avenue between McAllister and Grove Streets)

1. ESTABLISH – STOP SIGN

Hawes Street, southbound, at Innes Avenue, stopping the stem of this T-intersection

2. ESTABLISH – PERPENDICULAR PARKING

Hawes Street, west side, between Hunters Point Boulevard and Innes Avenue

3. ESTABLISH – STOP SIGN

Liberty Street, eastbound, at Noe Street, stopping the stem of this T-intersection

4. ESTABLISH – STOP SIGN

Rhode Island Street, northbound, at Division Street, stopping the stem of this T-intersection

5. ESTABLISH – RESIDENTIAL PERMIT PARKING AREA Z, 2 HOUR PARKING, 8 AM TO 6 PM, MONDAY THROUGH FRIDAY EXCEPT VEHICLES WITH AREA Z PERMIT

24th Street, both sides, between Dolores and Chattanooga streets (3700 block)

6. ESTABLISH – RESIDENTIAL PERMIT PARKING AREA J ELIGIBILITY

1548 through 1552 Haight Street

7(a). ESTABLISH – STOP SIGNS

Holly Park Circle, eastbound and westbound, at Murray Street, making this intersection an all-way STOP

Holly Park Circle, eastbound and westbound, at Bocana Street, making this intersection an all-way STOP

7(b). ESTABLISH – RED ZONES

Holly Park Circle, north side, at Murray Street, from staircase to 10 feet easterly *

Holly Park Circle, south side, at Bocana Street, from staircase to 10 feet westerly *

Items denoted with an asterisk () can be approved by the City Traffic Engineer after the public hearing and such approval constitutes the CEQA **Approval Action** under S.F. Administrative Code Section 31.04(h). Otherwise, the SFMTA Board will make the final approval at a later date based on the outcome at the public hearing.*

- 8(a). **ESTABLISH – RESIDENTIAL PERMIT PARKING ELIGIBILITY, AREA S**
Guerrero Street, west side, between Liberty Street and 20th Street
- 8(b). **ESTABLISH – RESIDENTIAL PERMIT PARKING ELIGIBILITY, AREA I**
Guerrero Street, east side, between Liberty Street and 20th Street
- 8(c). **ESTABLISH – RESIDENTIAL PARKING PERMIT BUFFER AREA S AND I, 2-HOUR PARKING, 8 AM TO 9 PM, MONDAY THROUGH FRIDAY (SIGNS ONLY)**
Guerrero Street, both sides, between Liberty Street and 20th Street (800 to 849 only)
- 9(a). **ESTABLISH – METERED YELLOW ZONE, 6-WHEEL COMMERCIAL LOADING 9AM TO 6PM, MONDAY THROUGH SATURDAY**
Union Street, south side, from 10 feet to 50 feet east of Columbus Avenue (establishes two metered yellow zones at meters #621 and #623) *
- 9(b). **ESTABLISH – BUS ZONE**
Union Street, south side, from 15 feet to 115 feet west of Columbus Avenue (extends the existing bus zone from 80 feet to 100 feet and removes one 20 foot metered yellow loading zone)
- 10(a). **ESTABLISH – BUFFERED BIKE LANES**
Clipper Street, eastbound and westbound, between Diamond Heights Boulevard and 30 feet east of Grandview Avenue. (Safe hits will be installed in the buffers, every 50 feet on center)
- 10(b). **RESCIND – TWO WAY LEFT TURN LANE**
ESTABLISH – LEFT TURN LANE
Clipper Street, eastbound, from 270 feet to 430 feet east of Grandview Avenue
