Ipinanukalang pagbabago sa kalsada

The SFMTA is proposing to install a transit lane on Hyde Street between McAllister and Market streets in the Tenderloin. This section of Hyde Street is one of the busiest transit streets in the city, connecting six bus routes to BART, the North Bay, and the SoMa, Potrero Hill and Bayview neighborhoods. Four parking spaces on the west side of Hyde Street would be removed to make room for the transit lane on these two blocks.

The proposed transit lane will go to public hearing on **August 18, 2023** and requires approval by the SFMTA Board. Additional improvements on Hyde Street are proposed as part of the Hyde Street Quick-Build project, which will be brought to public hearing later in the year after additional public outreach and design work is completed.

A public hearing for the proposal below to implement a transit lane on the west side of Hyde Street between McAllister and Market streets to improve Muni's reliability will be held online on August 18, 2023 at 10 a.m.

Comments will be considered when a determination is made whether to implement the change. After the hearing, proposals marked with a diamond (♦) can be approved by the City Traffic Engineer. Otherwise, the SFMTA Board of Directors will make the final approval at a later date based on the outcome of the public hearing. Certain, final SFMTA Decisions, whether made by the City Traffic Engineer or the SFMTA Board, can be reviewed by the Board of Supervisors pursuant to <u>Ordinance 127-18</u>.
