FOR PUBLIC HEARING

The Sustainable Streets Division of the San Francisco Municipal Transportation Agency will hold a public hearing on Friday, June 28, 2013 at 10:00 AM, in Room 416 (Hearing Room 4), City Hall, 1 Dr. Carlton B. Goodlett Place, San Francisco, CA 94102, to consider the following proposals:

ESTABLISH - YELLOW ZONE, 7AM TO 6PM, MONDAY THROUGH FRIDAY

"441" Hampshire Street, east side, from 114 feet to 134 feet south of 17th Street (20-foot zone, starting north of the driveway)

ESTABLISH - PART-TIME PASSENGER LOADING ZONE, 7AM TO 10PM, DAILY

146 McAllister Street, north side, from 221 feet to 263 feet east of Hyde Street, at parking meters #120 and #122 (42-foot zone)

ESTABLISH - YELLOW ZONE, 7AM TO 6PM, MONDAY THROUGH SATURDAY

1110 Harrison Street, north side, from 5 feet to 30 feet east of the west property line (25-foot zone)

ESTABLISH - GREEN ZONE, 9AM TO 6PM, MONDAY THROUGH SATURDAY

"1398" 10th Avenue, east side, from 10 feet to 32 feet north of the south property line (22-foot zone)

ESTABLISH – METERED LOADING ZONE, 8AM TO 6PM, MONDAY THROUGH SATURDAY

1415 Ocean Avenue, south side, from 31 feet to 61 feet west of the Granada Avenue crosswalk, at parking meter #1411 (30-foot zone)

ESTABLISH – PART-TIME PASSENGER LOADING ZONE, 5PM TO 10PM, TUESDAY THROUGH SUNDAY, WHEN VALET IS PRESENT

1358 Mason Street, east side, from 3 feet to 25 feet south of Pacific Avenue (22-foot zone)

ESTABLISH - YELLOW ZONE, 8AM TO 4PM, MONDAY THROUGH FRIDAY

"999" Pacific Avenue, south side, from 3 feet to 25 feet east of Mason Street (22-foot zone)

ESTABLISH – PART-TIME PASSENGER LOADING ZONE, 6PM TO 2AM, TUESDAY THROUGH SUNDAY

1516 Broadway Street, north side, from 60 feet to 98 feet west of Polk Street, at parking meter stalls #1508 and #1510 (38-foot zone)

REVOKE – PART-TIME PASSENGER LOADING ZONE, 8AM TO 8PM, EVERYDAY

3400 Laguna Street, east side, from 155 feet to 188 feet north of Francisco Street (33-foot zone)

<u>ESTABLISH – PART-TIME PASSENGER LOADING ZONE, 8AM TO MIDNIGHT,</u> <u>EVERYDAY</u>

3400 Laguna Street, east side, from 144 feet to 188 feet north of Francisco Street (44-foot zone) (this extension is contingent on raising dead driveways on Francisco Street and Bay Street to mitigate parking loss)

ESTABLISH – PART-TIME PASSENGER LOADING ZONE, 9AM TO 7PM, SATURDAYS AND 9AM TO 3PM, SUNDAYS

490 – 12th Avenue, east side, from 0 feet to 18.5 feet south of the north property line (extends existing 22.5 foot zone by 18.5 feet northerly)

ESTABLISH – METERED LOADING ZONE, 7AM TO 6PM, MONDAY THROUGH FRIDAY

500 Ellis Street, north side, from 11 feet to 48 feet west of Leavenworth Street, at parking meters #502 and #504 (37-foot zone)

Public hearings are held once a month at City Hall to legislate the installation of new colored zones. The zones usually recommended for this process are blue, green, white, and yellow. The purpose of the hearing is for residents to express their concerns regarding proposed changes affecting their streets. All interested parties are encouraged to attend. At the Public Hearing, the Hearing Officer will review the items and listen to residents, then make a final decision. Upon approval and payment of any applicable installation fees, zones will be installed as soon as scheduling permits.
