6. Introduction of New or Unfinished Business by Board Members

Director Cajina requested an informational item regarding safe parking sites presented with staff from the Department of Homelessness and Supportive Housing.



Director So shared about a recent visit to Kirkland Yard and thanked staff for their time.

Chair Eaken announced new members on the Train Control Upgrade Project Committee which includes Director Henderson and Director So joining Director Heminger and announced a new Vision Zero Committee which includes Director Hinze, Director Heminger, and Chair Eaken.

PUBLIC COMMENT:

Speaker expressed concern about Vision Zero.

Aaron Breetnor expressed concern for skateboarding and small wheel mobility, requesting that the Vision Zero Committee include a member focused on the subject.

Stacey Randecker hoped that the Train Control Upgrade Project Committee would focus on light rail activation and commented on Vision Zero.

Director Tumlin introduced Julie Kirschbaum, Director of Transit, and recognized Terry Fahey, Principal Infrastructure Development Manager, and staff on the Rail Activation Team. Director Tumlin shared about ridership data, recent community engagement awards, a proposed charter amendment related to mayoral approval of certain SFMTA proposals, Walk and Roll to school week, Muni Heritage Weekend, and about Senator Diane Feinstein's recent passing.

PUBLIC COMMENT:

Barry Taranto thanked Board Secretary Silva for her work and commented on the proposed charter amendment.

Speaker expressed concern about the Board's effectiveness.

Stacey Randecker suggested that Muni Heritage Weekend occur quarterly and expressed concern about the proposed charter amendment.

9. Public Comment

Speaker requested that the Board try their best.

Barry Taranto expressed concern about missing taxi stands at recent events and thanked Nick Chapman for his work.

Luke Bornheimer urged the Board to direct staff to update the design for a pedestrianized Valencia Street and requested a citywide no turn on red policy.

Tom Radulovich commented about placemaking and two-lane conversions of one-way streets.

Aaron Breetnor expressed concern about skateboard crashes and installation of traffic dots on the streets.

Marcelo Conseco expressed concern about the taxi medallion program and urged the Board to think of the real victims and not just the agency and the credit union.

Stacey Randecker expressed concern about Valencia Street and asked the SFMTA to make Valencia car-free.

Namdev Sharma expressed concern about taxi pick-up at the San Francisco Airport and urged the SFMTA to help medallion holders.

Chair Eaken recessed the meeting at 3:24pm and reconvened the meeting at 3:34pm.

Director Henderson left the meeting.

12. Presentation and discussion regarding a Vision Zero update. (Explanatory documents include a slide presentation.)



Uyen Ngo, Vision Zero Program Manager, and Shannon Hake, Speed Safety Camera Program Manager, presented the item.

PUBLIC COMMENT:

Carol Brownson commented on the Vision (VZ) toolkit and expressed concern about right turns on red lights.

Aaron Breetnor expressed concern about the VZ toolkit regarding low height architecture and shared about impediments for small wheel mobility.

Jodie Mederios thanked staff for their work on Assembly Bill 645 and asked the SFMTA to deliver on their promise of 50+ miles of work on high injury streets.

Cyrus Hall shared that current policy and plans are not working and asked the Board and staff to work with the Board of Supervisors and dig deeper.

Rick Gerling expressed concern about pedestrian safety, the need to control speed, and expressed support for more timed lights at 25mph.

Tom Radulovich expressed concern about street design and speeding in neighborhood streets, sharing that the SFMTA needs to move beyond quick build projects.

Barry Taranto encouraged the Board to watch a recent Police Commission hearing about citations and urged the SFMTA to reduce the number of transportation network companies (TNCs) on the road.

Stacey Randecker shared that the most prudent way to slow cars down is with concrete and asked why we were not doing more to make the city vibrant and safer.

Steven Bingham shared about his daughter being killed while biking to work and expressed concern about a lack of urgency to save lives.

Michael Zachs expressed concern for the continued numbers of pedestrian fatalities and urged the SFMTA to take a new approach.

Luke Bornheimer shared that the SFMTA must prioritize mode shift, urged staff to shift away from cars, and include a connected network of bike lanes.

Valient Shwartz expressed concern about VZ fatalities, sharing that the SFMTA is not doing the right thing and that more drastic changes are needed.



Speaker expressed concern about VZ not working and urged the Board to implement a No Turn on Red policy.

Herbert Weiner expressed concern about VZ and shared that it should be scrutinized more carefully.

Megan Rizali shared about a crash last year and asked the SFMTA to add more substantial improvements to dangerous intersections.

Director Cajina requested that future quarterly presentations include an update on recent VZ fatalities.

California Environmental Quality Act (CEQA) Appeal Rights under S.F. Admin. Code Chapter 31: For identified Approval Actions, the Planning Department or the SFMTA has issued a CEQA exemption determination or negative declaration, which may be viewed online at the Planning Department's website. Following approval of the item by the SFMTA Board, the CEQA determination is subject to appeal within the time frame specified in S.F. Administrative Code Section 31.16 which is typically within 30 calendar days. For information on filing a CEQA appeal, contact the Clerk of the Board of Supervisors at City Hall, 1 Dr. Carlton B. Goodlett Place, Room 244, San Francisco, CA 94102, or call 415.554.5184. Under CEQA, in a later court challenge, a litigant may be limited to raising only those issues previously raised at a hearing on the project or submitted in writing to the City prior to or at such hearing, or as part of the appeal hearing process on the CEQA decision.

<u>Board of Supervisors review of certain SFMTA Decisions:</u> Certain parking and traffic modifications as well as Private Transportation Programs that involve certain parking modifications can be reviewed by the Board of Supervisors. These decisions are subject to review within 30 calendar days after they are made by the SFMTA Board of Directors.
