Suggested topics for CAC agenda items included:

Motion 131112.01

The SFMTA CAC recommends that the SFMTA should have a zero-tolerance policy to people who trespass in the tunnels/subway and in the station areas after operating hours.

Motion 131112.02

The SFMTA CAC recommends that the Agency place a supervisor at the 4th & King Street platform to announce when the next T or N train will arrive based on actual train departure time, not the NextBus estimation during rush hour. The SFMTA CAC also recommends that the SFMTA work with Caltrain to coordinate train departure times to match the Caltrain arrival times.
