Director Tumlin introduced Jonathan Rewers, Chief Strategy Officer, who recognized the Facilities Stationary Engineer staff. Director Tumlin also introduced Viktoriya Wise, Director of Streets, who recognized the Twin Peaks Tunnel Team.

Director Tumlin then provided a state legislation update, shared about L Taraval service, an upcoming West Portal Ribbon Cutting event, increased capacity on the K Ingleside line, Walk and Roll to School Week, a new Youth Transportation Advisory Board (YTAB) cohort, and upcoming Muni Funding Working Group meetings.

Chair Eaken expressed appreciation for the L Taraval project and YTAB, requesting they come present at a future Board meeting.

Herbert Weiner expressed concern about limited resources and negative impacts to public transportation.

12. Amending Transportation Code Division II to establish a new definition for Recreational Large Vehicle to include camp trailers, fifth-wheel travel trailers, house cars, trailer coaches, mobilehomes, and recreational vehicles; establish the existing Division I violation for overnight parking restrictions (12 a.m. to 6 a.m.) of Recreational Large Vehicles citywide under certain conditions; remove the requirement that the San Francisco Municipal Transportation Agency Board of Directors designate each location where the restriction is established; authorize the Director of Transportation to install signage to effectuate the restriction and to permit removal of a Recreational Large Vehicle for a violation as authorized in Division I; authorize the Director of Transportation to issue rules and regulations to govern the location of signage authorizing removal; and make technical and



clarifying corrections; require the Director to make a written finding that such vehicles parked in the area have resulted in, or are likely to result in, impacts to traffic and circulation, public health and safety, or both; and give direction to staff to identify a future permit program to exempt Recreational Large Vehicles. (The Planning Department has determined that the proposed project is statutorily exempt from the California Environmental Quality Act [CEQA]. The proposed action is the Approval Action as defined by the SF Administrative Code Chapter 31. Explanatory documents include a staff report and resolution.)

Esther Lee, Legislative Aide for Supervisor Safai, urged the Board to reject or postpone the item and invited SFMTA to work with their office to identify more safe parking sites.

Calvin Yan, Legislative Aide for Supervisor Peskin, expressed opposition to the amendment.

Viktoriya Wise, Director of Streets, and Sam Dodge, Director of Street Response Coordination (SF Department of Emergency Management [DEM]), presented the item.

amendments to the legislation as shown on the final version of the legislation to state the expiration date and the SFMTA's policy related to permanent housing solutions; and approve as amended:

California Environmental Quality Act (CEQA) Appeal Rights under S.F. Admin. Code Chapter 31: For identified Approval Actions, the Planning Department or the SFMTA has issued a CEQA exemption determination or negative declaration, which may be viewed online at the Planning Department's website. Following approval of the item by the SFMTA Board, the CEQA determination is subject to appeal within the time frame specified in S.F. Administrative Code Section 31.16 which is typically within 30 calendar days. For information on filing a CEQA appeal, contact the Clerk of the Board of Supervisors at City Hall, 1 Dr. Carlton B. Goodlett Place, Room 244, San Francisco, CA 94102, or call 415.554.5184. Under CEQA, in a later court challenge, a litigant may be limited to raising only those issues previously raised at a hearing on the project or submitted in writing to the City prior to or at such hearing, or as part of the appeal hearing process on the CEQA decision.

<u>Board of Supervisors review of certain SFMTA Decisions:</u> Certain parking and traffic modifications as well as Private Transportation Programs that involve certain parking modifications can be reviewed by the Board of Supervisors. These decisions are subject to review within 30 calendar days after they are made by the SFMTA Board of Directors.
