Expiration Date: The new tow zone expiration date must be between the current expiration date and 31 days thereafter.

Start Address/End Address: The Start Address must be within the limits of the current Enforcement Zone. The Start Address must also be less than the End Address.

Days of Enforcement: Choose one or more days.

Click "Next" at the bottom of the form and click "Next" again to finalize/create the renewal.
